BRADIEY LEAD LOS ANGELES AP - The district attorney's office issued a fugitive complaint Tuesday against Edgar Eugene Bradley, 49, accused by New Orleans Dist. Atty. James Garrison of conspiring to kill President John F. Kennedy.

Bradley's lawyer, George Jensen, said Bradley will surrender in Municipal Court but will refuse to go to New Orleans.

'I will fight extradition tooth and nail.' Jensen said. 'I wont let him go to Louisiana.'

In an unsual news conference Dist. Atty. Evelle J. Younger said the complaint-based on a warrant obtained by Garrison in New Orleans-was a 'simple procedural act to get this person into court.' into court. " Younger said, "This does not indicate on our part as to the validity of the charge or the guilt or innocence of Mr. Bradley." Although Louisiana authorities urged a \$10,000 bond be set for Bradley, Younger said his office won't recommend any bond until the accused man appears in court.

The warrant "doesn't mention President Kennedy or any other alleged victim," the district attorney said.

He said the Louisiana warrant received by mail earlier Theodor Theo Tuesday, requiring the arrest of Bradley on a charge of criminal conspiracy to commit murder, had been found valid on its face. Issuing fugitive complaints in such circumstances is routine, Younger said.

LOS ANGELES AP - The District Attorney's Office issued Tuesday a fugitive complaint charging Edgar Eugene Bradley, 49, with criminal donspiracy to commit murder in the 1963 assassination of President John F. Kennedy.

The complaint was issued on a Louisiana warrant obtained by Jim Garrison, New Orleans district attorney.

Dist. Atty. Evelle J. Younger's office said in a statement that the purpose of the complaint is to bring Bradley before Municipal.

Earlier Tuesday, before the Sheriff's Office received the New Orleans warrant, Bradley said he would surrender to local authorities as soon as they 'pick up a telephone and call me.'

with activities "relative to criminal conspiracy to commit murde Bradley has denied any part in the assassination, which has been described by Garrison as a right wing plot. Garrison claims President Johnson and the FBI have been trying to undermine his murder. investigation.

Bradley is the second man against whom Garrison has brought criminal charges related to the assassination. A New Orleans business man, Clay Shaw, was charged with complicity in the murder which the Warren Commission report attributed solely to Lee Harvey Oswald. Oswald, a former Marine, was slain while being removed from the Dallas city jail two days after the assassination. Bradley, who lives in North Hollywood, has said he doesn't know anything about Garrison's investigation.

He said he had evidence that Oswald was feeding all the information he could obtain about the assassination plans to the Federal Bureau of Investigation. In Washington, the FBI declined comment on Garrison's

statements.

The district attorney also continued his criticism of Johnson, saying his investigation had turned up "callous, knowing concealment of the truth by high agencies of the federal government, including the President of the United States." JH803pcs Dec. 26
