

Garrison Case Figure's Denial

Des Moines

Lillie McMaines yesterday signed a deposition denying she went to a New Orleans party attended by Clay Shaw and Lee Harvey Oswald two months before the assassination of President Kennedy.

Oswald was the accused slayer of Mr. Kennedy.

Mrs. McMaines, 23, signed the deposition in a closed meeting with William Wegmann, an attorney for Clay Shaw. Shaw has been charged with conspiracy in the death of Mr. Kennedy on November 22, 1963, by New Orleans District Attorney Jim Garrison.

A chief witness against Shaw, Perry Russo has testified that Mrs. McMaines, then known as Sandra Moffit, was at a party in September, 1963, which was attended by Shaw and Oswald. The party allegedly was at the home of David Ferrie, another figure in Garrison's investigation who died in 1967.

The taking of the deposition was closed to the press. Mrs. McMaines' lawyer, Lex Hawkins, said she had denied attending the party or knowing Shaw or Oswald. She also said she did not meet Ferrie until January, 1965, when Russo introduced her to him,

in Iowa since March, 1967, when the New Orleans district attorney's office attempted to have her extradited from Omaha as a material witness in the case. Iowa has no agreement with Louisiana for extradition of material witnesses.

Mrs. McMaines' testimony is to be used in a suit filed by Shaw's attorneys asking the Federal court to stop the prosecution of Shaw in the State court.
