

## Haggerty's Case Eyed by State Panel

The Judiciary Commission of Louisiana will meet Tuesday to consider whether to look into the case of the vice raid in which Criminal Dist. Court Judge Edward Haggerty Jr. was arrested, it was reported today.

A high source said the ethics agency will decide at that time whether to hold a hearing on the incident.

A spokesman for the judiciary commission declined to comment on the report, saying the commission's proceedings are supposed to be confidential.

The ethics hearing would remain confidential unless it recommends the judge be removed from the bench.

The Dec. 17 raid at a New Orleans motel resulted in the arrest of Haggerty and 16th others. Haggerty was charged with obscenity, resisting arrest and soliciting for prostitutes, but he was acquitted at his trial last Monday.
