Judge Haggerty appeared on foot at the building at 9:15 a.m., 15 minutes before the start of the hearing and conferred with his attorney, Robert N. Zibilich, in the corridor butside the courtroom.

A stream of plainclothes police officers were seen leaving the building later in the morning, indicating they were the principal witnesses of the day. In contrast to the first

days of the hearing, newsmen had all but deserted the hearing.

Judge Haggerty and a number of other persons were arrested last Dec. 17 in a raid on a stag party at the DeVille Motel on Tulane Avenue. Since then, Judge Haggerty has been tried and acquitted has a fallow animinal district by a fellow criminal district court judge, Matthew F. Braniff, on charges of soliciting for prostitution, obscenity and resisting arrest.

· Probing his conduct is a panel of four judges, two at-torneys and a New Orleans businessman who comprise the Judiciary Commission for the state of Louisiana.

At the end of the hearing, for which 40 witnesses have been subpeonaed and which is expected to take the balance of the week, the commission will make its recommendation to the Louisiana Supreme Court on whether or not Haggerty should be involuntarily retired from office.
