Rackets figure Carlos Marcello was taken into custody today by federal officials after a U.S. Grand Jury indicted him on charges of illegal presence in the United States.

Marcello was led into the Wild Life and Fisheries build-ing in handcuffs about 2 p.m.

The indictment was returned before Federal District Judge James A. Comiskey at 11:30 a.m. at the request of the U.S. Attorney's office. The indictment was sealed and not released for publication

A WARRANT of arrest was issued for Marcello and the indictment was unsealed shortly after 2 p.m.

There was no word as to where Marcello was arrested.

## **Panel Named** For Challenge Of Life Probe

A three-judge federal court panel has been named to hear the suit of Life magazine reporter David Chandler to have declared unconstitutional the resolution creating a joint legislative committee to investigage charges brought against the state by Life.

The panel was named by Chief Judge John R. Brown of the U.S. Fifth Circuit Court of Appeals.

It is comprised of Circuit Judge John Minor Wisdom and District Judges Fred J. Cassibry and Lansing L. Mitchell.

No date has been set for a hearing on Chandler's petition.

Time Inc. and Chandler have been sued for \$10 million by Gov. John J. McKeithen on behalf of the state of Louisiana for reporting alleged Mafia influence over state officials.

This suit was filed in state court at Baton Rouge but was subsequently removed to federal district court.
