

Holland, S. M.**Sequence Number:**

- 1 Hand drawn sketch of Dealey Plaza showing the location of Holland during the assassination. Referred to as Holland Exhibit A in the Warren Commission records.
- 2 Photograph taken by Holland the day after the assassination from his location the prior day. Good view of the crowd in the plaza. Referred to as Holland Exhibit B in the Warren Commission records.

Holt, Sally**Sequence Number:**

- 1 Allegedly recorded one photograph of the TSBD during the assassination. Film was exposed to light during the removal of the film packet from the camera. Extent of the damage not known.
- 2 Additional exposed frames are not known at this time.

Hood, Jim**Sequence Number:**

- 1 Recorded several black and white stills of a pool of blood located on the steps leading up the grassy knoll.
- 2 Within several days, two FBI agents confiscated the photographs and negatives exposed by Hood. The photographs and negatives were never returned to the Dallas Morning News.
- 3 This information concerning the pool of blood was brought to the attention of Hood by co-workers Charles Mulky and Jerry Coley.
