"It makes me so damn mad
I can't stand it," Mrs. Mitchell
told a Gazette reporter. "He
could have done a great deal
for the whole vote." She said
Mr. Fulbright helped sway the
vote against Judge Carswell.

She called his vote against confirmation "a damn shame."

"I want you to crucify Fulbright and that's it," Mrs. Mitchell said. The Gazette opposed confirmation of Judge Carswell and it has strongly supported Mr. Fulbright of Arkansas in the past.

Mrs. Mitchell is a native of Pine Bluff, Ark.

"I am from Arkansas," she toyd the newspaper. "It is my home state and Mr. Fulbright does not represent the state." She said she had talked to three or four persons from Arkansas who were "very influential" and that they had told her they would "disown" the Senator if he did not vote to confirm Judge Carswell.

"He is not representing the people of Arkansas," she said. "I love Arkansas and I want everything possible for my state."
