WASHINGTON--FIRST ADD ZAMBIA-BRIDGE (A162WX)

DESTRUCTION OF THE BRIDGE WOULD HAVE CAUSED A SERIOUS INTER-  
NATIONAL SHORTAGE OF COPPER AND FORCED A SUBSTANTIAL INCREASE IN  
ITS PRICE, THE FBI SAID.

THE FBI SAID THE MEN, ROLF DUENBIER, 36, VICE PRESIDENT OF A  
GERMAN METALS FIRM, AND JAY AUBREY ELLIOTT, 31, A PROFESSIONAL  
DIVER, WERE CHARGED WITH VIOLATION OF THE NEUTRALITY ACT WHICH  
PROHIBITS CONSPIRING IN THE UNITED STATES TO INJURE OR DESTROY  
PROPERTY LOCATED IN A FOREIGN COUNTRY WITH WHICH THE UNITED STATES  
IS AT PEACE.

THE FBI SAID THE BRIDGE WAS LOCATED NEAR MAZABUKA, ZAMBIA.  
THE BRIDGE WAS DESCRIBED AS A VITAL LINK ON THE ONLY RAILROAD USED  
TO TRANSPORT ZAMBIAN COPPER TO EAST AFRICAN PORTS FOR SHIPMENT TO  
WORLD MARKETS.

ZAMBIA IS SECOND ONLY TO THE UNITED STATES IN THE WORLD PRODUCTION  
OF COPPER.

THE FBI IDENTIFIED THE TWO MIAMI MEN AS PHILIP ARMSTRONG AND  
PAUL WOODBURN CAUDELL, BOTH YACHT CAPTAINS AND MARINE ENGINEERS.  
THE FBI EMPHASIZED THAT THE TWO MEN ARE NOT DEFENDANTS IN THE  
CASE AND SAID THEY WERE COOPERATING FULLY IN THE INVESTIGATION.

THE FBI SAID DUENBIER AND ELLIOTT OFFERED THE MIAMI MEN \$25,000 PLUS EXPENSES TO BLOW UP THE BRIDGE.

THE FBI SAID DUENBIER AND ELLIOTT SPECIFICALLY WERE CHARGED WITH VIOLATING TITLE 18, SECTION 956 OF THE NEUTRAL SECURITY ACT. PENALTY FOR THE VIOLATION OF THAT SECTION IS A FINE OF NOT MORE THAN \$5,000 AND 0 IMPRISOENT 0

MORE THAN \$5,000 AND OR IMPRISOENT OF NOT MORE THAN THREE YEARS.

THE TWO ACCUSED MEN WILL BE ARRAIGNED AS SOON AS POSSIBLE, FBI ANNOUNCEMENT SAID, BEFORE THE U.S. COMMISSIONER AT NEW YORK CITY.

FBI DIRECTOR J. EDGAR HOOVER SAID DUENBIER WAS BORN IN AACHEN, GERMANY, ON OCT. 30, 1930, AND CAME TO THE UNITED STATES SIX YEARS AGO. HE BECAME A NATURALIZED CITIZEN IN 1963 AND CURRENTLY LIVES AT 262 DORCHESTER ROAD IN SCARSDALE, N.Y. HE IS MARRIED AND HAS TWO CHILDREN, THE FBI SAID.

ELLIOTT WAS BORN IN 1935 AT WHEELING, W.VA., THE FBI SAID. HE WAS DESCRIBED AS AN EMPLOYE OF DUENBIER'S FIRM AND TRAVELS WIDELY. THE FBI DID NOT IDENTIFY THE FIRM.
