Mitchell Controlled Secret GOP Fund

Early

John V. Mitchell personally controlled the Republican fund to secure the Election of 1972, a Post has learned. Beginning in the 1971, almost a year before the election, Mitchell became the campaign manager for the GOP. Mitchell personally controlled the fund, a source in the White House said yesterday. Two of them were identified as former Secretary of Commerce Maurice H. Stans, now finance chairman of the President's campaign, and Jeb Stuart Magruder, manager of the Nixon campaign before Mitchell took over and now a deputy director of the campaign. The other two are a high White House official now involved in the campaign and a campaign aide outside of Washington.

...ance-raising operations against the Democrats. It could not be determined yesterday exactly what individual projects were funded by the secret account.

But sources said FBI agents uncovered several in the course of their Watergate investigation. Those projects were described by one source as "not necessarily illegal," although "definitely very embarrassing if anybody found out they were."

In addition, the sources said, a small amount of money from the fund was used by several persons for nonintelligence activities—usually because the money in Stans' safe represented quickly obtainable cash for travel.
