

# N.A.A.C.P. PONDER'S NIXON OUSTER BID

Resolution Is Given Little  
Chance of Adoption

INDIANAPOLIS, July 5—Delegates to the 64th convention of the National Association for the Advancement of Colored People here have been asked to adopt a resolution calling for the impeachment of President Nixon, the resignation of Vice President Agnew and new Presidential elections.

The resolution was circulated today by members of the Philadelphia branch. The resolution is expected to be introduced at the final session tomorrow, but national officials of the association gave it little chance of adoption by the full convention.

## 'Election Fraud'

The resolution urges Congress to nullify the 1972 Presidential election "due to widespread election fraud necessitating the holding of a new Presidential election."

The resolution said that the Senate Watergate hearings and grand jury "indicate that illegal surveillance, theft, deliberate sabotage and the infiltration of political organizations have violated the sanctity and shaken the security of the electoral process in the United States."

It said, "The confessed duplicity by numerous White House staff members and officials committed to re-elect the President in these criminal activities expose as lies President Nixon's repeated assertions of his ignorance of these activities and the subsequent efforts by his staff to impede the criminal investigations into these activities."

## 'Only Consistent'

"We note that the Watergate crimes are only consistent with the political history and style of Richard M. Nixon, a history that clearly indicates his willingness to use invasions of privacy, racist innuendoes, political espionage and sabotage when those tactics stand to advance his ideas (for example, the baneful 'Southern strategy') and strengthen his personal political power."

"The revelations of the Watergate, coupled with the crisis of constitutionally delegated patterns of authority, clearly indicate that the peaceful progress, social expectations and ideals of our democracy have been maliciously subverted by dishonesty, insensitivity and crime. His subversion is especially detrimental to the hopes of black and poor people," the resolution continued.

A call for impeachment of the President was made last night in a speech by Represent-

ative Parren J. Mitchell, Democrat of Maryland. Mr. Mitchell said the House should begin impeachment proceedings because the Senate Watergate committee had uncovered information that makes impeachment unavoidable.

## College Mergers

The convention will also take up tomorrow a resolution dealing with the merger of black and white state colleges, a highly emotional issue among blacks at the convention, many graduates of the black schools that might disappear with merger.

However, national N.A.A.C.P. policy is aimed at dismantling dual colleges, mostly in the South. The resolution offered by the N.A.A.C.P. leadership directed local branches to involve themselves in the dismantling of dual educational systems to assure merger of racially identifiable colleges and universities, protection of black administrators, teachers and students, and compositions governing boards that reflect the racial compositions of the states.

The leadership expects no problem tomorrow in getting through the college resolution and beating down the impeachment resolution, if the latter even gets to the floor of the convention.

Nathaniel Jones, N.A.A.C.P. general counsel, said the organization would step up its war on de facto segregation. The convention has been asked to approve a \$300,000 emergency fund, to be financed by assessments on member branches, to underwrite the legal protection of blacks, considered jeopardized by "the power and wealth of the Federal, state and local governments arrayed against the N.A.A.C.P. as it seeks to desegregate public schools and to otherwise protect Negro Americans."
