Dear Js, from the depths not of despair but of one of those situations that can lead to it and fresh from the waste of at least two hours I write to ask one of those favors I hate to ask. I'm never diplomatic in these things, so dongt fear a major deal. If you can do this it will not be. What I have been looking for is my instant analysis of the WG original indictment. I wrote it on receipt of the copy, the date of which I do not rewall. I have gone through every one of the dozens of files in which I could have put it or Howard could have refiled it, without success, even cross-reference. I have found only my 9/16/73 memo, which is not that one. The one benefit from all of this is that I found a copy of my original letter to Clawson, which HR did misfiled, and a remarkable coincidence I now think has significance, the notice of depossiti taking by Williams, mailed 10 days before the long-delayed indictment. Because I recognized that the emotional drain and strain of the Sheoherd exchange, is unrealized, might have dulled my sensitivity, I went over most probably files at least twice. Now I'll be writing immeditely, as immediately as getting Lil in a little over an hour, taking her someplace she has to go, and GL's pearly word of tinight, what I plan on this. Lil will type it when she finishes about 12 pages, so I'll do it pronto, too pronto. Not having the original analysis for the writing, I'll want it only for comparison, to see if I missed anything of significance. So, if you can find the copy I would have sent you and can lend it back or make a copy, I'd much appreciate it. NOW, if this present a problem, I am without doubt that I'll spot more than enough without it, so skip it. I mean only if in your filing you can retrieve without problem. The date of the indict. is 9/15/73 ... Organizational problems are more severe than Shepherd said. In this case, after remeading the opener, "The Boil That Burst" (bows where earned) I decided that I'd have to go into the dishonesty and inadequacy of the indictment immediately. Ordinarily, in a less complex book and concept (weaving GL in), it would have been next I decided that in this case It had to depart from the method on an analystworking with what was known when it was known, a means of addressing GL's participation, not knowledge, and possible command, to prepare the reader for th mindboggling. I am by no means confident this is now correct, but I think it is as of now. The uncertainty makes me edgier than Shepherd's letter did. I guess another fact that influenced

If inspired by what she had just typed, it can'tbe more than an occasional word I missed on reading and might be from something I'd said re GL's coming subCheckers performance. ... There will be less from the Post regulars, all of whom are on vacation, the kind of thing GL could also wantrik anticipate. It is probably time elsewhere. I haven't even looked at onday's fat batch of NYTimes from HR. It is the only thing they can all do.... Are you not fascinated that GL flew back to hated WH long enough to sign a bill and pretend he was always for it when he had delayed it four years then, into a thunderstorm, flew back to his Berchtesgatten to complete final review? I am. ... Also learned that the Post's files are separately locked. Unti Sussman returns I cangt get what I'd been promised, the xerox of the Cushman bug transcript, the thing that led to the conversation today. I'll all for that kind of security ... . Nashville Tennes sean reported phone me yesterday for a Ray story based on a reader' inquiry, whatwhappened to the suit I'd filed of which he'd read three years ago? A perfect peg for a timely story for which this black reporter took more than an half hour. He phoned back to say that Siegenthaler (A Search for Justice) personally killed. What odds!
