Dear Jim, 9/14/73

May have time to answer your letter of 9/9 before going for Lil.

With it was a letter to the editor by Ony Paxwell. I have been in touch with her. She is brilliant and I think a very human and fine human. I also feel she is hungup on what I think is a common misapprehension about "mental illness" as she is by her excellent grasp of scientific things. She was forced out of the Lawrence Radiation Labos where she was a glass blower by noise. She figures and perhaps 100% correctly, that it is infrancise. Recall her emphasis on the extremely low frequency she reported, 16 cycles? There is a point at which all the science becomes ireelevant and where the human has to react. If there is no reaction, there is mental illness. t is sick not to react. It is not sick to react. The shrinks she has seen and those to whom she has been subjected by the compensation people fear this whole area and the wantis have said things she reagrds as nasty. In fact they are, but if she could unfetter her mind, they could win the case for her, her opposition could. Her lawyer apparently is also on the unimaginative side, as are all the shrinks of whom I've heard and the few to whom I've spoken. (There is one guy at the Nat Institute of Health who used some of my animal work in a scientific conference at M more than a decade ago, but he would not talk to me now if I tried, as I did couple years ago.) We have flask-flood warmings today, so I'm glad I finished up a uniform cut yesterday...If I could get one of the new lightweight chain saws and could get the 4 hp tractor-mower working (fried thinks he can fix) I d do most of our heating with the trees that have to come down, all when Lil isn't how by taking t'writer in front fireplace.

Glad to be able to send the few things I have. Second of McCord's pieces now due. Guess Lesar will send. I've asked him to send you Miami Hear Hezald Fiorini/Buchanan story becausse the copy I have is partly indistinct.

Thanks for the coming Ramparts. I still-noe more- wonder about Prouty as the military's anti-CIS cutting edge.

I had noticed all you say about the tapes except that I had missed what Je didn't, on the Butterfield timing and I have not been able to reach any conclusion. The one thing I did immediately and intended writing you about you know about from a later story, the Jencks angle. I assume all this began with Nixon, not that there is a question of how much he may have learned ex poste facto. Therefore I also assume there are many who are not only guilty but are aware of his personal guilt, More than the Berlin Wall. He has to have them not face durance vile to be certain they won t talk for if they talk, they have totalk about him. He can't stand another Dean.
