Thanks for the tape with your 8/31. Your probably right in saying both great moments should be savored together. I have not read the text yet, either and only in part because I haven't had time. I thinkiit will get me in the mood when I want to write a little more than I have about it.

I also have a notion that he may flip. I think he is suddenly the nothing in his own recognition that he has spent his entire life proving to himself that he isn't. That is the strange thing about this man. He had none of the redeeming human qualities of a Hoover or a Harding of a Coolidge. He is essentially evil and not competent. Otherwise, that is. Nothing except where he is very bad. Sociopath.

Now he is out of it, with nothing to do except force a few calls on those he knows are also nothings but his kind, so they'll be polite.

And there has to be a limit to how many times he can read Six Crises.

Wish I remembered his earlier career better. Only unscrupulousness stands out. I suppose some kind of paranoia is inevitable in red-hunting, where you have to tell yourself it is real to keep going, and that from there other varieties are an easier step. I find myself wondering if he merely made that marvelous lesson of the Checkers speech the reality, that in order to live with himself afterward he had to believe he was the innocent victim, not a crook and a liar.

Glad you are keeping up on his seclusion. I've trouble keeping up with anything now including the grass and weeds even with a drought. I'll not be surprised at some dramatic development prior to his taking any witness stand. He may decide, even at some level below consciousness, that he ought to be sick rather than have to lie when he is no longer President and powerful. If he takes the stand he may be in real trouble.

Especially when indictment is not yet impossible.

I've been pushing too hard to have time to think and it is tiring me. I have a little time before WW IV is out and I've been trying to pick up WG stuff, bits I can do for later assembling, and catching up on other accumulations. But I feel it too much today, more than for several, so I'm going to have to sleep more. At least for a while. There have been partocular emotional drags, too.
