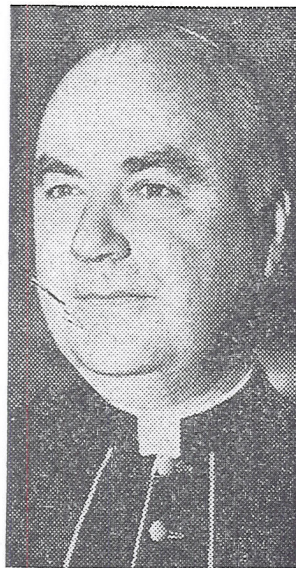


Sketches of the Panel Investigating Attica



ROBERT BUDGE McKay

Dean of New York University School of Law since 1967 . . . chairman of the New York Civil Liberties Union and the Citizens' Union . . . Nationally known authority on constitutional law and the criminal justice system who has frequently served on fact-finding committees studying critical issues for the state and city governments . . . Chairman of the 1965 Advisory Council on Reapportionment, which prepared the plan to redistrict legislative election districts in accord with the Supreme Court's one-man, one-vote ruling . . . Graduate of Yale University Law School . . . Born in Wichita, Kan., Aug. 11, 1919



EDWIN B. BRODERICK

Bishop of the Roman Catholic Diocese of Albany . . . Consecrated in May, 1969 . . . Favored state aid to parochial schools during last Legislature, an issue the Governor also staunchly supported . . . Born Jan. 16, 1917, in New York City . . . Ordained in 1942 after graduating from St. Joseph's Seminary in Yonkers . . . Assistant pastor at St. Patrick's Cathedral here, 1947 to 1954 . . . Secretary to Cardinal Spellman until 1964 when named president of St. Joseph's . . . In 1967 was appointed auxillary bishop of the Archdiocese of New York.



ROBERT LEE CARTER

Former general counsel of the National Association for the Advancement of Colored People . . . Resigned after 20 years in 1968 in a dispute over dismissal of a white lawyer on his staff who criticized Supreme Court as not going far enough in civil rights rulings . . . Now a senior partner in the New York law firm of Poletti, Freidin, Prashker, Feldman & Gartner . . . In his early fifties . . . Married . . . Has two sons . . . Lives in Harlem . . . President of the National Committee Against Discrimination in Housing . . . A co-chairman of the National Conference of Black Lawyers.



Amalia Rivera-Munoz

An actress, singer and dancer of Yabucoa, P. R., retired from the American stage in 1939 when she married and became Mrs. Mariano Guerrero . . . For nearly 20 years she traveled all over Latin America with her husband, now retired but then a chemical company vice president . . . Settled at 1035 Fifth Avenue . . . She became active in the Hudson Guild and the Community Service Society . . . In 1956 she founded and became president of the Society of Friends of Puerto Rico to bring to mainlanders' awareness Puerto Rican achievements in the creative arts.

Executive director of Reality House, a rehabilitation center for narcotics addicts . . . Born 42 years ago in Harlem Hospital . . . Is a former narcotics addict and convict . . . As a youth lived in Washington Heights and attended public schools there . . . Dropped out of school in World War II to work as longshoreman . . . In 1967 was a member of a group that split with Exodus House, a narcotics treatment center, to form Reality House . . . Divorced and now lives in the Bronx with his second wife, the former Carole Rogavin, and their two young sons.

BURKE MARSHALL

Headed the Justice Department's civil rights division from 1961 to 1965 at the request of President John F. Kennedy and then Attorney General Robert F. Kennedy, forty-nine years old today . . . Named deputy dean of the Yale University Law School in April, 1970 . . . born in Plainfield, N. J. . . . Graduate of Phillips Exeter Academy and Yale Law School . . . Practiced law in Washington for 10 years before assuming Justice Department post . . . Author of book "Federalism and Civil Rights," published in 1964



Walter Nathan Rothschild Jr.

A 51-year-old native New Yorker . . . resigned two years ago as president of Abraham & Straus, to spend more time on social causes . . . shortly after was named chairman of the New York Urban Coalition, a nonprofit organization seeking solutions to the problems of poverty and urban decay . . . Graduated 1942 cum laude from Harvard with bachelor of arts degree . . . Was associated with Bloomingdale's before joining A.&S. in 1950 as manager of its Hempstead store . . . Married to former Virginia Trott . . . They have four children and live in Laurel Hollow, L. I.

DOROTHY WADSWORTH

The wife of Dr. Robert H. Warsworth, a dentist in Rochester, and the mother of two daughters, she describes herself as a "fairly full-time community volunteer" . . . Born in Geneseo, N. Y. . . . Fifty years old . . . Graduated from Mount Holyoke College, where she majored in economics and sociology . . . President of Monroe County Neighborhood Health Center, set up to establish network of centers in county . . . Active with many community organizations, from Planned Parenthood to local public broadcasting group, the Junior League

WILLIAM LEE WILBANKS

A native of Temple, Tex., now a graduate student in criminal justice at the State University of New York, Albany . . . Has a bachelor's and master's degree in Bible from Abilene Christian University . . . Has first draft of his master's theses in criminology and corrections at Sam Houston State University, Huntsville, Tex., and Albany . . . Both concerned with predicting parole performance statistically . . . Says he "fell into" the field, worked one summer in state penitentiary at Huntsville . . . Thirty years old, unmarried . . . Hopes to teach, do research.
