WASHINGTON, FEB. 18 (AP)-MEMBERS OF CONGRESS MADE NEW DE-MANDS TODAY FOR AN IMMEDIATE, FULL-SCALE INVESTIGATION OF THE U.S. CENTRAL INTELLIGENCE AGENCY'S INVOLVEMENT WITH PRIVATE GROUPS.

AT THE SAME TIME, CONGRESSIONAL SUPPORTERS OF THE UNDERCOVER AGENCY'S OPERATIONS DEFENDED ITS ACTIVITIES AGAINST THE LATEST IN A SERIES OF DISCLOSURES AND CRITICISMS OF THE CIA'S DEALINGS WITH STUDENT GROUPS, FOUNDATIONS AND A LABOR UNICE.

AMONG THE LATEST DEVELOPMENTS:

--THE CIA REPORTEDLY CHANNELED TO THE AMERICAN NEWSPAPER GUILD MORE THAN \$1 MILLION FOR THE UNION'S INTERNATIONAL ACTIVITIES OVER THE PAST SEVERAL YEARS. ARTHUR ROSENSTOCK, PRESIDENT OF THE AFL-CIO UNION, TOLD A REPORT IN NEW YORK THE GUILD HAD NO KNOWLEDGE THAT ANY OF THE HONEY CAME FROM THE CIA. "THE CHARGES ARE COMPLETELY UMFOUNDED, ACCORDING TO THE BEST OF OUR KNOWLEDGE," HE SAID. "THE CIA WAS NOT IN THIS OR A PART OF IT, CERTAINLY NOT TO OUR KNOWLEDGE."

THE CIA HAD PROVIDED UP TO SO PER CENT OF THE NSA BUDGET AND USED NSA LEADERS AND STAFF TO GATHER INTELLIGENCE.

IN CONGRESS, THE CHAIRMAN OF THE DEMOCRATIC STUDY GROUP,
REP. FRANK THOMPSON JR., D-N.J., SAID "THE MORE DISCLOSURES THERE
ARE; THE MORE NEED THERE IS FOR AN IMMEDIATE INVESTIGATION BY A
JOINT COMMITTEE OF CONGRESS."

THOMPSON, SAYING HE WAS SHAKEN BY THE LATEST REPORTS,

DECLARED "IT'S OBVIOUS THAT A GREAT MANY GROUPS AND PEOPLE HAVE BEEN
COMPROMISED" BY THE CIA ACTIVITIES. THE STUDY GROUP HE HEADS IS AN
ORGANIZATION OF LIBERAL DEMOCRATIC HOUSE MEMBERS.

REP. WILLIAM F. RYAN, D-N.Y., SAID "I THINK THERE'S NO QUESTION BUT THAT THE CONGRESS SHOULD STEP IN AND INVESTIGATE THE ENTIRETY OF THE CIA'S INVOLVEMENT IN DOMESTIC AFFAIRS AND WHAT IT'S DOING ABROAD.

"THE QUESTION BEFORE THE COUNTRY IS THE EXTENT TO WHICH AN AL-MOST-SECRET, ALMOST-INDEPENDENT AGENCY OF THE GOVERNMENT HAS BEEN AFFECTING OUR POLICY AND HAS ALSO BEEN SUBVERTING THE VALUES OF A FREE SOCIETY."

NSA LEADERS LAST NIGHT ACCUSED THE CIA OF LAYING "AN ETHICAL TRAP FOR YOUNG MEN OF GREAT INTEGRITY" WITH MONEY, DRAFT DEFERMENTS AND THE THREAT OF JAIL.

BUT THE CHAIRMAN OF THE HOUSE SUBCOMMITTEE THAT SUPERVISES THE CIA, REP. L. MENDEL RIVERS, D-S.C. SAID HIS GROUP HAS KEPT WATCH ON ALL CIA ACTIVITIES AND HAS FOUND NO WRONGDOING.

RIVERS, CHAIRMAN OF THE HOUSE ARMED SERVICES COMMITTEE AS WELL AS ITS CIA SUBCOMMITTEE, SAID OF THE ALLEGED JAIL THREATS:
"I DON'T BELIEVE THE CIA DID THAT."

THE SOUTH CAROLINA DENOCRAT SAYS HE'S IN DAILY TOUCH WITH THE CIA. "I LIVE JUST FIVE MILES FROM CIA HEADQUARTERS (IN NEARBY VIRGINIA) AND IT'S NOT UNUSUAL FOR ME TO GO OVER AND HAVE BREAKFAST WITH THOSE BOYS."

RIVERS' SUBCOMMITTEE QUESTIONED CIA DIRECTOR RICHARD HELMS AT LENGTH YESTERDAY AND SAID AFTERWARD THAT NO STUDENTS OR NSA STAFF HAD BEEN USED FOR ESPIONAGE. RIVERS SAID HE KNOWS NOTHING OF STATEMENTS BY NSA LEADERS THAT SOME OF THEM HAVE BEEN GIVEN DRAFT DEFERMENTS.

AS FOR PAYMENT OF MONEY TO STUDENTS, REPUBLICAN SUBCOMMITTEE MEMBER WILLIAM H. BATES OF MASSACHUSETTS SAID: "OF COURSE THEY HAVE RECEIVED MONEY--THAT WAS THE IDEA."

BUT HE ADDED THAT THE CIA "DID NOT GO TO THIS ORGANIZATION (THE NSA) -- THE ORGANIZATION ASKED FOR HELP."

THE SUBCOMMITTEE ISSUED A STATEMENT YESTERDAY COMMENDING
THE CIA FOR GIVING MONEY TO THE STUDENTS AND SAID THE PURPOSE WAS
"TO COUNTER COMMUNIST ATTEMPTS TO TAKE OVER" STUDENT ORGANIZATIONS
IN THE NONCOMMUNIST WORLD.

THE CURRENT FUROR WAS TOUCHED OFF BY DISCLOSURE EARLIER THIS
WEEK THAT FOR ABOUT 15 YEARS THE CIA, OPERATING THROUGH FOUNDATIONS,
HAS BEEN SECRETLY HELPING FINANCE THIS ORGANIZATION OF COLLEGE
STUDENTS, THE NATION'S LARGEST. NSA OFFICIALS HAVE INSISTED THAT
ONLY A HANDFUL OF THEIR NUMBER KNEW OF THE ARRANGEMENT.

RIVERS SAID HIS SUBCOMMITTEE WILL CONSIDER: "ANYTHING THAT'S WORTHY OF OUR COGNIZANCE. BUT HE ADDED: "WE CAN'T OPEN THE HEART OF THE CIA TO THE PUBLIC."

SOME MEMBERS OF THE SENATE ALSO ARE DEMANDING A THOROUGHGOING INVESTIGATION OF THE CIA.

ONE OF THE INTELLIGENCE AGENCY'S STRONGEST SENATORIAL CITIES,
EUGENE J. MCCARTHY, D-MINN., SAID "WE MUST CONTINUE TO PRESS
FOR GREATER CONGRESSIONAL CONTROL" OVER THE CIA BECAUSE IT COULD
BECOME AN "ARM OVER WHICH NOBODY CAN BE HELD RESPONSIBLE."

DEMOCRATIC LEADER SEN. MIKE MANSFIELD OF MONTANA SAID RE HOPES AN APPROPRIATE SENATE COMMITTEE WILL LOOK INTO THE ALLEGATIONS "SO INCIDENTS OF THIS NATURE (INVOLVING THE NSA) SHOULD NOT ARISE IN THE FUTURE."

BUT SEN, JOHN G. TOWER, R-TEX., SAID THE WHOLE THING HAS BECOME OVERBLOWN, "WITH A GOOD DEAL OF THE EMOTIONALISM SQUEEZING ASIDE RATIONAL ANALYSIS."

WASHINGTON, FEB. 18 (AP)-TOP OFFICIALS OF THE NATIONAL STUDENT ASSOCIATION CONCURRED WITH DEMANDS BY SOME MEMBERS OF CONGRESS TODAY FOR A FULL-SCALE INVESTIGATION OF THE U.S. CENTRAL INTELLIGENCE AGENCY'S INVOLVEMENT WITH PRIVATE GROUPS.

THE ASSOCIATION SAID THAT PENDING DEVELOPMENT OF SUCH AN IN-QUIRY, IT WILL TURN OVER ITS RECORDS TO THE SENATE FOREIGN RELATIONS COMMITTEE.

AT THE SAME TIME, CONGRESSIONAL SUPPORTERS OF THE UNDERCOVER AGENCY'S OPERATIONS DEFENDED ITS ACTIVITIES AGAINST THE LATEST IN A SERIES OF DISCLOSURES AND CRITICISMS OF THE CIA'S DEALINGS WITH STUDENT GROUPS, FOUNDATIONS AND A LABOR UNION.

EUGENE GROVES, NSA PRESIDENT, SAID THE ASSOCIATION'S RECORDS WILL BE HANDED TO THE SENATE COMMITTEE TO HOLD PENDING AN OFFICIAL INVESTIGATION. HIS ANNOUNCEMENT CAME AFTER AN ALL-DAY MEETING OF THE NSA'S SUPERVISORY BOARD, HELD TODAY BEHIND CLOSED DOORS.

GROVES SAID HE HOPED THE SENATE FOREIGN RELATIONS COMMITTEE "WILL BE ABLE TO CONDUCT A FULL INVESTIGATION."

THE STUDENT ORGANIZATION'S PRESIDENT ISSUED A STATEMENT.

"THE NATIONAL STUDENT ASSOCIATION," GROVES' STATEMENT SAID,
"IS TURNING ITS PAST RECORDS OVER TO THE SENATE FOREIGN RELATIONS
COMMITTEE TO HOLD UNTIL SUCH TIME AS THE CONGRESS SHALL DETERMINE
AN APPROPRIATE MEANS TO EXAMINE THE SUBJECT OF THE RELATIONSHIP
BETWEEN THE CIA AND PRIVATE ORGANIZATIONS ENGAGED IN INTERNATIONAL RELATIONS.

"WE HOPE THIS COMMITTEE WILL BE ABLE TO CONDUCT A FULL INVESTIGATION."

FREQUENTLY AND EMPHATICALLY OPPOSED MANY U.S. FOREIGN POLICY POSITIONS, AND IN DOMESTIC AFFAIRS HAS MAINTAINED AN AGGRESSIVELY LIBERAL STANCE.

NSA HAS URGED A HALT TO AMERICAN BOMBING IN NORTH VIETNAM,
ALTHOUGH IT HAS SUPPORTED VIETNAMESE WAR EFFORT. IT CONDEMNED
THE 1965 U.S. INTERVENTION IN THE DOMINICAN REPUBLIC, HAS CALLED
FOR ADMISSION OF RED CHINA TO THE UNITED NATIONS, AND HAS
DEMANDED ABOLITION OF THE HOUSE COMMITTEE ON UN-AMERICAN ACTIVITIES.

ITS POLICY TRADEMARK IS STRONG SUPPORT OF ACADEMIC FREEDOM.

BUT NSA HAS DECLARED ITSELF ON A WIDE RANGE OF DOMESTIC QUESTIONS.

IN THE AREA OF CIVIL RIGHTS IT HAS SUPPORTED SIT-INS AND CIVIL DISOBEDIENCE. IT BACKED THE FORMATION OF THE STUDENT NON-VIOLENT COORDINATING COMMITTEE (SNCC), BUT HAS NOT ENDORSED THE NEWLY EMERGED CONCEPT OF "BLACK POWER."

ON MANY CAMPUSES IT HAS CLASHED IDEOLOGICALLY WITH THE LARGEST CONSERVATIVE YOUTH GROUP, YOUNG AMERICANS FOR FREEDOM (YAF). WHEN THE CIA SUBSIDY STORY BROKE THIS WEEK, YAF QUICKLY AMOUNTED AN ATTACK ON NSA.

YAF CALLED ITS RIVAL "A LEFTWING GROUP WITH CONSISTENTLY RACIAL POSITIONS." IT DEMANDED AN IMMEDIATE CONGRESSIONAL INVESTIGATION OF THE LINK WITH CIA AND AN INTERNAL REVENUE SERVICE REVIEW OF NSA'S TAX-EXEMPT STATUS.

LOSS OF THE TAX EXEMPTION ALMOST CERTAINLY WOULD PUT THE ASSO-CIATION OUT OF BUSINESS; SOME OF ITS LEADERS, IN FACT, HAVE VOICED FEAR THAT BAD PUBLICITY MAY ALREADY HAVE DOOMED THE NSA. YAF ANNOUNCED IT IS ASKING THE 45 CONGRESSIONAL MEMBERS OF ITS NATIONAL ADVISORY BOARD TO SEEK A SPECIAL INQUIRY INTO POSSIBLE VIOLATIONS BY NSA OF THE FEDERAL LAW THAT BARS TAX EXEMPT GROUPS FROM SEEKING TO INFLUENCE LEGISLATION--AND WHETHER CIA'S SUBSIDY AMOUNTED TO A VIOLATION OF THE SAME LAW.

"THERE CAN BE NO JUSTIFICATION FOR THE USE OF AMERICAN TAXPAYERS' MONEY TO SUPPORT THIS KIND OF RADICAL LEFTWING GROUP," SAID
A STATEMENT ISSUED IN WASHINGTON BY ALAN MACKAY OF BOSTON, NATIONAL
VICE PRESIDENT OF YAF.

"THE CONGRESS HAS A DUTY TO SEE THAT THOSE RESPONSIBLE FOR THIS POLICY IN THE CIA ARE REMOVED AND THAT SUCH SUBSIDIES ARE ENDED."

YAF OFFERED TO NEWSPAPERS WHAT IT DESCRIBED AS "A SPECIAL 55PAGE REPORT ON NSA WHICH HAS BEEN COMPILED OVER THE LAST FIVE
YEARS AND DOCUMENTS FULLY THE ACTIVITIES OF THIS GROUP," AS WELL
AS PHOTOGRAPHIC COPIES OF NSA'S FEDERAL TAX RETURNS FROM 1952
THROUGH 1964.
