WASHINGTON, FEB. 19 (AP)-AN ATTORNEY FOR THE CENTRAL INTELLIGENCE AGENCY SAID TODAY HE DOESN'T FEEL THE GOVERNMENT WILL PROSECUTE NATIONAL STUDENT ASSOCIATION OFFICIALS WHO HAVE DISCLOSED THEIR RELATIONSHIP WITH THE SPY ORGANIZATION. ✓

LAWRENCE R. HOUSTON, CIA GENERAL COUNSEL, SAID, HOWEVER, THAT THIS DOES NOT MEAN THE STUDENTS "HAVE IT CARTE BLANCHE" TO TELL EVERYTHING ABOUT THEIR DEALINGS WITH THE INTELLIGENCE AGENCY.

"THESE FELLOWS WERE, AFTER ALL, UNDER A CONFIDENTIAL RELATIONSHIP...I CAN'T SAY WHETHER THEY ARE UNDER A FORMAL AGREEMENT...BUT I CAN'T CONCEIVE THE GOVERNMENT WOULD PROSECUTE ANY OF THEM FOR WHAT THEY HAVE SAID SO FAR," HOUSTON SAID IN A TELEPHONE INTERVIEW.

THE CIA ATTORNEY SUGGESTED, HOWEVER, THAT THE STUDENTS-- CAUGHT UP IN THE CONTROVERSY ABOUT RECEIVING CIA FUNDS TO FINANCE SOME OF THEIR ACTIVITIES--SHOULD RECEIVE ADVICE FROM THEIR OWN LAWYERS ON THE QUESTION.

HOUSTON REPEATED THAT HE COULD NOT FORESEE ANY GOVERNMENT ACTION AGAINST THE NSA MEMBERS, POINTING OUT THAT "INTENT" TO BREACH NATIONAL SECURITY MUST BE SHOWN BEFORE A PROSECUTION CAN BE ACHIEVED.

HE SAID HE CONSIDERED "THESE BOYS WERE PUSHED INTO A CORNER" AND THAT THEIR STATEMENTS SO FAR GIVE NO GROUNDS FOR PROSECUTION.

THE CIA ATTORNEY EMPHASIZED THAT HE HAD NOT BEEN IN TOUCH WITH ANY MEMBER OF THE NSA.

OVER THE WEEKEND, MEANWHILE, THE AMERICAN NEWSPAPER GUILD (AFL-CIO) DENIED IT HAD KNOWINGLY ACCEPTED \$1,004,000 IN GRANTS FROM FOUNDATIONS USED AS CONDUITS BY THE CENTRAL INTELLIGENCE AGENCY, AND RICHARD HUNT, AN ASSISTANT DEAN OF HARVARD UNIVERSITY, SAID HE WAS UNAWARE AN ORGANIZATION HE ESTABLISHED HAD RECEIVED FUNDS FROM A BOSTON FOUNDATION IDENTIFIED AS A CHANNEL FOR CIA MONEY.

HUNT, ASSISTANT DEAN OF THE HARVARD GRADUATE SCHOOL OF ARTS AND SCIENCES, SAID HE ESTABLISHED THE INTERNATIONAL SOCIAL-ECONOMIC FUND IN PITTSBURGH, PA., HIS HOME TOWN, IN 1957 WITH FUNDS FROM PERSONAL RESOURCES, AND GRANTS, TO AID PROJECTS IN UNDEVELOPED AREAS, INCLUDING LATIN AMERICA AND AFRICA.

BROWN SAID TODAY HE RECEIVED ABOUT \$20,000 FROM THE FREDERICK BROWN FOUNDATION OF BOSTON, IDENTIFIED BY GOVERNMENT SOURCES AS A CHANNEL FOR CIA FUNDS, IN 1964, BUT DECLARED HE DIDN'T KNOW OF ITS ALLEGED CIA CONNECTION.

HUNT SAID THE BROWN FOUNDATION "SEEMED TO BE INTERESTED IN THE SAME PROJECT"--SUPPORT OF COOPERATIVE ENTERPRISES, AGRICULTURAL COOPERATIVES, ASSISTING IN TRAINING OF TRADE UNION LEADERS, SUPPORT OF VARIOUS ADULT EDUCATION PROJECTS IN VARIOUS LATIN AMERICAN COUNTRIES AND AFRICA.
