URGENT

DETROIT, FEB. 20 (AP)-DETROITER SOL A. DANN, FORMER ATTORNEY FOR JACK RUBY, ASKED TODAY AN IMMEDIATE INQUIRY BY A FEDERAL OR LOUISIANA GRAND JURY INTO WHETHER A PLAN WAS DEVELOPED IN NEW ORLEANS WHICH CULIMNATED IN ASSASSINATION OF PRESIDENT JOHN F. KENNEDY.

SUCH A PLAN WAS REPORTED SATURDAY BY NEW ORLEANS DISTRICT ATTORNEY JIM GARRISON, WHO SAID, "THERE WERE OTHER PEOPLE BESIDES LEE HARVEY OSWALD INVOLVED."

A U.S. INVESTIGATING COMMISSION HEADED BY CHIEF JUSTICE EARLY WARREN SAID ITS EXHAUSTIVE PROBE SHOWED THERE WAS NO CREDIBLE EVIDENCE THAT ANYONE ELSE BUT OSWALD WAS IMPLICATED IN THE 1963 ASSASSINATION.

RUBY WAS THE CONVICTED KILLER OF OSWALD, SHOT DOWN AS TELEVISION CAMERAS WERE FOCUSED ON HIS TRANSFER FROM ONE DALLAS, TEX., JAIL TO ANOTHER TWO DAYS AFTER THE PRESIDENT WAS SLAIN.

RUBY DIED LAST MONTH OF CANCER WHILE APPEALING HIS MURDER CONVICTION. UNTIL THE END HE INSISTED NO CONSPIRACY EXISTED AND HE DID NOT KNOW OSWALD. RELATIVES SAID THAT OPINIONS OF CONSPIRACY HELD BY SOME PEOPLE PREYED ON RUBY'S MIND.

DANN WIRED GARRISON TODAY: "RESPECTFULLY REQUEST YOU IMMEDIATELY ARRANGE TO IMPANEL FEDERAL OR LOUISIANA SPECIAL GRAND JURY TO INQUIRE INTO ANY INFORMATION OR EVIDENCE THAT PERSONS OTHER THAN OR IN ADDITION TO OSWALD WERE GUILTY OF MISPRISION OR CONSPIRACY IN CONNECTION WITH PRESIDENT KENNEDY'S ASSASSINATION."

THE DICTIONARY DESCRIBES MISPRISION AS "NEGLECT OR WRONG PERFORMANCE OF ODDICIAL DUTYZ OR "CONCEALMENT OF TREASON OR FELONY BY ONE NOT GUILTY" OR "SEDITIONOUS CONDUCT AGAINST THE GOVERNMENT OR THE COURTS."

DANN SENT AN IDENTICAL TELEGRAM TO LOUISIANA ATTORNEY GENERAL JACK P. GREMILLION, EXCEPT THAT IT ASKED INQUIRY INTO "JIM GARRISON'S INFORMATION OR EVIDENCE."

GARRISON WAS QUOTED IN AN ASSOCIATED PRESS INTERVIEW SATURDAY FROM NEW ORLEANS AS SAYING OTHERS WERE INVOLVED BESIDES OSWALD AND THAT "NEW ORLEANS WAS A FACTOR IN THE PLANNING BEYOND DOUBT."

THE PARISH (COUNTY) DISTRICT ATTORNEY SAID A CONTINUING INVESTIGATION HAD CONVINCED HIM THE WARREN COMMISSION'S FINDING WAS INCORRECT.

"WE ALREADY HAVE THE NAMES OF THE PEOPLE IN THE INITIAL PLANNING," GARRISON WAS QUOTED AS SAYING. "WE ARE NOT WASTING OUR TIME AND WE WILL PROVE IT. ARRESTS WILL BE MADE. CHARGES WILL BE FILED AND CONVICTIONS WILL BE OBTAINED."

DANN WAS BROUGHT INTO THE RUBY CASE BY RUBY AND HIS RELATIVES, INCLUDING DETROITER EARL RUBY, MONTHS AFTER JACK'S CONVICTION.

OSWALD LIVED IN NEW ORLEANS FOR SIX MONTHS SHORTLY BEFORE THE DALLAS ASSASSINATION NOV. 22, 1963. WHILE IN NEW ORLEANS HE WAS ACTIVE IN THE FAIR PLAY FOR CUBA COMMITTEE IN NEW ORLEANS. HE ALSO HAD VISITED RUSSIA AND HAD MARRIED A RUSSIAN GIRL WHILE THERE.
