Hypnosis Used on Russo

NEW ORLEANS - (AP) Perry R. Russo, 25, a state witness in District Attorney Jim Garrison's assassination conspiracy case against Clay Shaw, testified today that he had been hypnotized three times in the office of the Orleans Parish (county) coro-

Despite intensive questioning by Shaw's attorney, Russo said he could not remember the exact days the hypnosis took place. Russo denied that he was ever under hypnosis during his testimony thus far in the preliminary hearing for Shaw which started Tuesday.

Garrison has accused Shaw of conspiring with Lee Harvey Oswald and David W.

Garrison has said the conspiracy talk in Ferrie's apartment was heard by a "confidential informant" who repeated the information after being given a truth serum in the coroner's office. Presumably the informant is Russo, because he has tesfied to hearing such a conversation.

F. Irvin Dymond, a de-ense attorney crossfense examining Russo, asked the witness if he had ever been hypnotized.

"Yes, sir," Russo replied.

Q. By whom?

A. Dr. Fatter. (Dr. Esmond Fatter is a private physician associated with the coroner's office.)

Q. Were you hypnotized on March 1?

A. I don't remember:

Q. What did Dr. Fatter tell you to do after you came out of hypnois?

A. He said to come out with a smile on my face.

Russo said the hypnosis occurred between Feb. 24 and March 13.

ed by Garrison March 1 and booked on a conspiracy charge. Purpose of the pre-liminary hearing is to find out if Garrison's case against Shaw is story enough to go to trial.

Dymond asked the young Q. Did you ever hear of insurance salesman if he had been aware that Ferrie was arrested shortly after the Kennedy assassination.

A. No sir.

Q. Did David Ferrie ever mention the assassination of President Kennedy?

A. No sir. After the assassination there was a blank spot. I didn't see Ferrie for a while. For about seven or eight months I didn't see

Q. How many times did you see Ferrie between the assassination of President Kennedy and the death of Ferrie?

A. Four, five, six times or so. He seemed to me a broken man after that. I don't know why. But he seemed, like a broken man. He talked about the district attorney's office a few times. He was starting to build up antagonism to the police. I

Dymond asked Russo why he didn't question Ferrie about the alleged assassination plot.

A. It was typical of Dave as a walking encyclopedia. You didn't ask questions. He knew it all.

NEW ORLEANS - Dean Andrews Jr., an attorney who says he once handled some legal matters for Lee Harvey Oswald, appeared before the Orleans Parish grand jury today for the second time in connection with the District Attorney's probe of the Kennedy assassination.

Meanwhile, Andrews was suspended as an Assistant District Attorney in suburban Jefferson Parish.

A subpena was also issued for Gordon Novel to appear before the grand jury. Novel, who owns the Jamaican Village, a bar on the fringe of the French Quarter, had not previously been linked with the case.

Andrews was asked by a newsman if he knew why he had been summoned by the Grand Jury a second time. He shook his head but did not reply.

"What are you supposed to know?" he was asked,
