COLUMBUS, OHIO, APRIL 3 (AP)-A FORMAL FUGITIVE CHARGE WAS FILED TODAY AGAINST GORDON NOVEL, WANTED BY A NEW ORLEANS PROSECUTOR INVESTIGATING THE ASSASSINATION OF PRESIDENT JOHN F.KENNEDY.

NOVEL, A 29-YEAR-OLD FORMER NEW ORLEANS NIGHT CLUB OPERATOR, VOWED TO FIGHT EXTRADITION TO LOUISIANA "IF NECESSARY TO THE UNITED STATES SUPREME COURT."

A TOP AIDE TO GOV. JAMES A.RHODES SAID, HOWEVER, THAT OHIO SELDOM REFUSES TO RETURN TO OTHER STATES PERSONS ARRESTED IN OHIO ON OTHER CHARGES. NOVEL WAS PICKED UP SATURDAY IN SUBURBAN GAHANNA AT THE REQUEST OF NEW ORLEANS DIST. ATTY. JIM GARRISON, WHO IS CONDUCTING THE ASSASSINTION INQUIRY.

GAHANNA POLICE FILED A FORMAL AFFIDAVIT TODAY NAMING NOVEL AS A FUGITIVE FROM JUSTICE, ON THE BASIS OF A NEW ORLEANS CHARGE OF CONSPIRACY TO COMMIT BURGLARY.

NOVEL'S COLUMBUS LAWYER, JERRY WEINER, CONTENDED NOVEL WAS NOT A FUGITIVE BECAUSE "HE DID NOT FLEE LOUISIANA TO AVOID PROSECUTION."
HE SAID THE CHARGE WAS FILED AFTER NOVEL HAD LEFT LOUISIANA.

WEINER, WHO SAID HE HAD NEVER MET NOVEL UNTIL SATURDAY NIGHT, SOUGHT TO GET HIS CLIENT FREED ON \$10,000 BOND FROM THE COLUMBUS CITY JAIL, WHERE HE HAS BEEN HELD SINCE SHORTLY AFTER HIS ARREST.

WEINER, WHO SAID HE HAD NEVER MET NOVEL UNTIL SATURDAY NIGHT, SAID HE HOPED TO ARRANGE BOND FOR HIS CLIENT, BUT NOVEL REMAINED IN JAIL AFTER AN APPEARANCE BEFORE MUNICIPAL JUDGE WILBUR SHULL. SHULL CONTINUED THE \$10,000 BOND SET SATURDAY NIGHT, AFTER NOVEL WAS BOOKED FOR INVESTIGATION.

AT HIS COURT APPEARANCE, NOVEL SAID, "I USED TO WORK FOR GARRISON, IN FACT I DID SOME OF THE INVESTIGATING IN THIS SO-CALLED PLOT. I'VE GOT A LOT OF CHARGES OF MY OWN TO MAKE ABOUT HIM."

BEFORE WEINER REACHED THE COURTROOM. AT ONE POINT NOVEL SAID OF

REPORTS HE MIGHT RETURN TO NEW ORLEANS VOLUNTARILY, "I DID NOT INTEND TO DO THAT BECAUSE OF THIS CUBAN..."

AFTER WEINER ARRIVED, HE AGREED TO A 30-DAY CONTINUANCE ON THE FUGITIVE CASE WHILE HE SOUGHT TO GET A HEARING ON THE EXTRADITION REQUEST.

THAT MAN, EUGENE WOODS, HAS BEEN SOUGHT BY OHIO FOR MANY MONTHS,

BUT MCELROY SAID, "I DON'T KNOW THAT WE WILL TRADE ONE FOR THE OTHER."

NOVEL'S COLUMBUS ATTORNEY, JERRY WEINER, SAID LAST NIGHT HE HOPED TO POST BOND SOON AFTER A SCHEDULED PRELIMINARY COURT HEARING FOR HIS CLIENT. WEINER SAID THE BOND MONEY WAS BEING PROVIDED BY FRIENDS OF NOVEL IN NEW ORLEANS. HE DID NOT NAME THEM.

AFTER HIS ARREST SATURDAY NIGHT IN SUBURBAN GAHANNA,
THE 29-YEAR-OLD FORMER NEW ORLEANS NIGHT CLUB OPERATOR VOWED

WEINER SAID THE FIRST STEP LIKELY WOULD BE THE FILING OF AN AFFIDAVIT WITH OHIO GOV. JAMES A.RHODES STATING REASONS WHY NOVEL DOES NOT WANT TO GO BACK.

NOVEL WAS ARRESTED ON A FUGITIVE FROM JUSTICE WARRANT OBTAINED BY GAHANNA OFFICIALS FROM THE OFFICE OF NEW ORLEANS DIST.

ATTY, JIM GARRISON, WHO IS CONDUCTING THE ASSASSIONATION INQUIRY.

GARRISON'S OFFICE SAID THE WARRANT RESULTED FROM A CHARGE OF "CONSPIRACY TO COMMIT THE SIMPLE CRIME OF BURGLARY" OF A MUNITIONS DUMP IN HOUMA, LA., ABOUT 40 MILES SOUTHWEST OF NEW ORLEANS.

EARLIER, GARRISON HAD ISSUED A WARRANT SEEKING NOVEL AS A MATERIAL WITNESS IN THE ASSASSINATION INVESTIGATION.

NOVEL WAS ARRESTED AS HE ENTERED THE OFFICE OF A NEWS SERVICE OPERATED BY RICHARD L. PAUGH, A LOCAL COLUMNIST AND TELEVISION NEWSMAN.

PAUCH DENIED ANY CONNECTION WITH NOVEL BUT SAID HE HAD INTERVIEWED HIM ABOUT TWO WEEKS AGO.

GAHANNA MAYOR PAUL VAN AUKEN SAID NOVEL HAD HIS SUITCASES
STORED IN THE OFFICE AND "APPARENTLY WAS PREPARING TO
LEAVE BY PLANE SATURDAY NIGHT."

VAN AUKEN SAID HE HAD NO IDEA WHERE NOVEL MIGHT HAVE BEEN PLANNING TO GO, BUT NOTED THAT HIS FIANCEE WAS OUT OF TOWN, POSSIBLY IN CHICAGO.

THE FIANCEE, MISS ABBY MULLIGAN FOLUMBUS, WAS LISTED AS THE MOST LIKELY REASON FOR NOVEL'S BEING HERE. HER BROTHER SAID MISS MULLIGAN, A FORMER BUNNY AT THE PLAYBOY CLUB IN CHICAGO, HAD BEEN GIVEN A RING BY NOVEL.

NOVEL ALSO REPORTEDLY HAD BUSINESS TIES HERE. A BUSINESS ACQUAINTANCE SAID HE WAS DEVELOPING AN "ANTI-BUGGING" DEVICE IN CONJUNCTION WITH A LOCAL ELECTRONICS FIRM. HE ALSO WAS REPORTEDLY TO CONFER WITH REPRESENTATIVES OF THE RESTAURANT AND BAR BUSINESS HERE.

THE BOND OF \$10,000, SET BY MUNICIPAL COURT JUDGE DEAN STRABAUGH, WAS \$45,000 LESS THAN RECOMMENDED BY GARRISON.

NOVEL HAS DENIED ANY KNOWLEDGE OF THE ALLEGED KENNEDY
ASSASSINATION CONSPIRACY AND SAYS HE HAS REFUSED TO GO BACK TO
NEW ORLEANS BECAUSE OF "INTIMIDATION AND HARASSMENT."
