NEW ORLEANS, APRIL 4 (AP)-CLAY L. SHAW, EXPRESSING CONFIDENCE THAT HE WILL BE ACQUITTED, WILL BE ARRAIGNED TOMORROW ON A CHARGE OF CONSPIRING TO MURDER PRESIDENT JOHN F. KENNEDY.

SHAW, 54-YEAR-OLD RETIRED EXECUTIVE, SAID THAT WHILE AWAITING THE TRIAL, IN WHICH HE WILL "BE PROVED INNOCENT, OF COURSE," HE IS WRITING A PLAY. SHAW SPOKE AT A NEWS CONFERENCE WHICH DEFENSE AT-TORNEY EDWARD WEGMANN SAID HAD BEEN ARRANGED TO PERMIT PHOTO-GRAPHS FOR FUTURE USE.

F. IRVIN DYMOND, ANOTHER DEFENSE ATTORNEY, SAID COURT GUIDELINES ISSUED EARLIER IN THE DAY BY DIST. JUDGE EDWARD A. HAGGERTY JR. WOULD BE RESPECTED.

JUDGE HAGGERTY, WHO WILL PRESIDE AT SHAW'S ARRAIGNMENT AND TRIAL, ORDERED "ALL ATTORNEYS, POLICE INVESTIGATORS, WITNESSES AND ANY PUBLIC EMPLOYES" CONNECTED WITH THE CASE NOT TO MAKE ANY STATE-MENTS ABOUT SHAW'S GUILT OR INNOCENCE OR TO COMMENT ON THE EVIDENCE.

THE JUDGE ALSO BANNED CAMERAS AND RECORDING DEVICES IN THE COURT-ROOM.

MEANWHILE, SERGIO VINCENTE ARCACHA SMITH, 44, FORMER ANTI-CAS-TRO LEADER, WAS FREED ON \$1,500 BOND IN DALLAS, TEX., YESTERDAY AFTER HIS ARREST ON A WARRANT FROM DIST. ATTY. JIM GARRISON WHO BEGAN THE ASSASSINATION PROBE.

THE WARRANT CHARGED ARCACHA WITH CONSPIRING WITH DAVID W. FER-RIE, AND GORDON NOVEL, 29, FORMER NEW ORLEANS BAR OWNER, TO BURG-LARIZE A MUNITIONS PLANT IN HOUMA, LA., IN 19'61. FERRIE, FORMER AIRLINE PILOT IDENTIFIED BY GARRISON AS A KEY FIGURE IN THE AS-SASSINATION PROBE, DIED FEB. 22.

NOVEL; ARRESTED IN GAHANNA, OHIO, LAST SATURDAY, WAS HELD IN COLUMEUS, OHIO, IN LIEU OF \$10,000 BOND.
