NEW ORLEANS, APRIL 8 (AP)-DIST. ATTY. JIM GARRISON HAS A WEEK TO ANSWER A MOTION TO QUASH A PERJURY INDICTMENT AGAINST DEAN A. ANDREWS JR., ACCUSED OF LYING BEFORE THE GRAND JURY PROBING AN ALLEGED CONSPIRACY IN THE ASSASSINATION OF PRESIDENT JOHN F. KENNEDY.

"ALL THE INDICTMENT SAYS IS THAT MY CLIENT COMMITTED PERJURY," SAM ZELDEN, ANDREWS' DEFENSE LAWYER, SAID YESTERDAY. "THEY ARE SUPPOSED TO SET FORTH IN THE INDICTMENT WHERE HE PERJURED HIMSELF."

THE GRAND JURY INDICTED ANDREWS, A SUSPENDED ASSISTANT DISTRICT ATTORNEY IN NEIGHBORING JEFFERSON PARISH, ON CHARGES HE LIED WHILE TESTIFYING LAST MARCH 16.

ANDREWS TOLD THE WARREN COMMISSION INVESTIGATING THE ASSASSINATION THAT HE WAS ASKED BY A MAN NAMED CLAY BERTRAND TO REPRESENT LEE HARVEY OSWALD IN DALLAS.

ANDREWS SAID HE HAD NO IDEA AS TO BERTRAND'S WHEREABOUTS AND THE FBI WAS UNABLE TO FIND HIM. GARRISON CONTENDS CLAY L. SHAW USED CLAY BERTRAND AS AN ALIAS.

SHAW, 54, A RETIRED NEW ORLEANS EXECUTIVE, PLEADED INNOCENT LAST WEDNESDAY TO A CHARGE OF CONSPIRING TO MURDER THE PRESIDENT.

IN ANOTHER DEVELOPMENT, SEN. RUSSELL LONG, D-LA., SAID IN NEW ORLEANS HE THINKS THE FBI PROBABLY HAS SOME INFORMATION WHICH WOULD PROVE WHAT GARRISON HAS BEEN SAYING ABOUT A CONSPIRACY.

LONG, WHO SAID HE WAS THE ONE WHO SUGGESTED TO GARRISON HE INITIATE THE PROBE, ADDED: "I THINK THE FBI INFORMATION WILL BE MADE AVAILABLE, IF NOT IMMEDIATELY, IN DUE COURSE."

LONG SAID HE DOES NOT THINK THE WARREN COMMISSION CONSPIRED TO WITHHOLD ANYTHING FROM THE PUBLIC.

HE SAID, "THEY DID THEIR DUTY AS THE GOOD LORD SHOWED THEM THE LIGHT TO DO IT. BUT THEY JUST SIGNED A REPORT HANDED THEM BY THE FBI."

GARRISON CONTENDS THAT OSWALD, DAVID W. FERRIE AND SHAW MET IN FERRIE'S NEW ORLEANS APARTMENT IN SEPTEMBER, 1963 TO TALK OVER AN ASSASSINATION ATTEMPT.

THE WARREN REPORT SAID OSWALD, A FORMER NEW ORLEANS RESIDENT, KILLED THE PRESIDENT AND THAT THERE WAS NO CREDIBLE EVIDENCE A CONSPIRACY WAS INVOLVED.
