THE ASSASSINATION

On November 20, the day before President Kennedy's assasination, Bergman was released from prison. At that time I did not think there was a connection

between these two events.

However, two weeks later I received a notice that my parole was coming up for review; and a visit from a representative of the Board, who told me I would be back in Canada and working by Christmas 1963. (Ed.Note: Members of a Pardons and Paroles Board are not known

for such definite statements.)

On November 24, I was driven in a truck to Huntsville and released to the Immigration authorities. Two officers to Houston Airport and handed drove me me a full pardon. I was then flown, as the only passenger, in a plane to Chicago, unaware of why I had been pardoned. From there I was flown by American Airlines to Detroit, taken across the border to Windson and handed border to Windsor, and handed a ticket to Toronto.

The first reply I received was from James Bergman, revealing to me some startling facts. He stated that, through his organization he had been made aware of a conspiracy to assasinate President of a conspiracy to assasinate President Kennedy, prior to the actual killing. His information was, that Kennedy was kill ed because he was attempting to have Red China recognized by and admitted to

the United Nations.

The R.C.M.P. were aware of the letter's content because they had asked to read it even before I saw it. How ever, they would not tell me what

should do next.

About two weeks later they advised, research writer, Hugh Greig that the C.B.C. should drop the story and forget about it, as it was being handled by the Department Of External Affairs.
