NEW ORLEANS (AP)-LAWYERS FOR CLAY L.SHAW RENEW THEIR LEGAL
ATTACK TODAY ON THE GRAND JURY INDICTMENT CHARGING HIM WITH
CONSPIRING TO MURDER PRESIDENT JOHN F.KENNEDY.
CRIMINAL DIST. COURT JUDGE EDWARD HAGGERTY SAID HE EXPECTS TO RULE
BY NEXT MONDAY ON THE DEFENSE MOTION TO QUASH THE INDICTMENT.
SHAW'S FOUR LAWYERS OPENED A BROAD ATTACK ON THE INDICTMENT,
CONCENTRATING MAINLY ON THE METHOD OF SELECTING ORLEANS PARISH GRAND JURORS.

SHAW, 54, A TALL, RETIRED BUSINESS EXECUTIVE, CHAIN-SMOKED IMPASSIVELY THROUGH MOST OF THE PROCEEDINGS, FREQUENTLY WHISPERING

THE INDICTMENT AGAINST SHAW WAS ISSUED MARCH 22. HE IS THE ONLY MAN CHARGED IN DIST. ATTY. JIM GARRISON'S CONTROVERSIAL PROBE OF AN ALLEGED NEW ORLEANS CONSPIRACY TO MURDER THE PRESIDENT--WHO WAS ASSASSINATED IN DALLAS IN 1963.

WHEN THE PRE-TRIAL HEARING OPENED MONDAY, SHAW'S LAWYERS SET OUT IN AN EFFORT TO PROVE THREE MAIN POINTS: THAT WOMEN ARE SYSTEMATICALLY INCLUDED, AND THAT DRAWINGS FROM THE JURY WHEEL MAY BE ILLEGAL. SEVERAL VARIATIONS FROM THE LEGALLY PRESCRIBED METHOD OF CHOOSING GRAND JURORS WERE DEVELOPED DURING QUESTIONING OF THE JURY PHILIP J.MYER. A MEMBER OF THE COMMISSIONERS.

PHILIP J.MYER, A MEMBER OF THE COMMISSION WHICH DREW THE NAMES OF 75 PROSPECTIVE JURORS FOR THE GRAND JURY WHICH INDICTED SHAW, TESTIFIED THERE MIGHT HAVE BEEN ONLY 500 TO 600 NAMES IN THE BRASS WHEEL AT THE TIME.

THE COMMISSIONERS ALSO TESTIFIED THEY HAD NOT FOLLOWED COURT ORDERS
TO ACQIRE ADDITIONAL NAMES OF PROSPECTIVE JURORS FROM LISTS SOLICITED
FROM THE VOTER REGISTRAR, NEGRO CARNIVAL AND CIVIC ORGANIZATIONS AND
LARGE EMPLOYERS.

"I DON'T KNOW WHERE YOU'VE BEEN ALL THIS TIME; YOU WERE THERE WHEN
I REQUESTED YOU DO THESE THINGS, "JUDGE HAGGERTY TOLD NOEL J.
RADA, THE COMMISSION CHAIRMAN.

THE 23 WITNESSES CALLED ON THE FIRST DAY OF THE HEARING INCLUDED
SEVEN CRIMINAL DISTRICT COURT JUDGES, WHO WERE QUESTIONED AS TO HOW
THEY GO ABOUT EMPANELING GRAND JURIES.

IN ADDITION, ALL 12 MEMBERS OF THE GRAND JURY WHICH INDICTED
