Garrison's 'Money Men' Willing to Keep Paying

# New Orleans

Two principal contributors to the private fund that finances District At-torney Jim Garrison's in-quiry into the Kennedy assassination vow they'll keep putting up the money as long as they believe he has a case.

"We're in hopes that it's a short term deal," said Willard E. Robertson, a wealthy New Orleans civic leader, "but we're not going to dis-band until Mr. Garrison's case is proved or disproved."

Robertson referred to Truth and Consequences of New Orleans, Inc., an organization of 50 businessmen which has been backing Garrison since the district attorney's undercover investigation became public knowledge last February. 'TOOL'

At that time, Garrison said he couldn't maintain the secrecy he needed if public funds were used in the probe. Such expenditures would be a matter of public record.

"I knew he couldn't conduct it in a goldfish bowl," " said Joseph M. Rault Jr., head of Rault Petroleum Corp., and a member of Truth and Consequences. "I believe he should be allowed

Garrison disputes the verdict issued by the Warren Commission after its official investigation of the murder of President John F. Kennedy, shot in Dallas on Nov. 22, 1963.

Robertson, who is chair-man of Truth and Consequences, said last June 9 that the organization had donated \$9418 to Garrison's probe, and that all but \$386 had been spent. This month, he said Garrison's expenditures had totaled "a little over \$10,000, but not much more." Garrison, he added, "has the courage to carry through an investigation most Americans think should have been reopened."

er he does not want the truth to be brought out," Garrison said in an interview. "Per-haps he can explain better than I can why his political career is so important."

Garrison charged that the New York Senator "has done everything he could to obstruct the investigation and I have to conclude that he feels the development of truth about the assassination, catching the real assassins of Jack Kennedy, would inter-fere with his politicial ca-reer."

#### GUESS

The Louisiana official also said no other members of the Kennedy family had contacted his office "and there is no, way for me to guess what their attitude is."

Garrison, who claims he knows the names of men involved in the assassination, said "most of them are in Texas and Dallas particularly where they are protected - one, by the Dallas law enforcement establishment and, two, by the Federal gov-ernment."

"It is quite apparent to me "will be brought to justice." that for one reason or anoth- Garrison said their names would be made public "and I'll tell them in advance so they can start planning to do whatever they want."

Garrison said the President's slaying November 23, 1963, in Dallas "was a Nazi operation whose sponsors included some of the oil-rich milli9naires in Texas." He added that "elements of the Dallas police force are clearly involved."

### MINUTEMEN

He said the right-wing Minutemen organization was not responsible for the assassina-tion but that "key individu-als" in the alleged plot were members of the group.

"I have to emphasize that no single organization was involved," Garrison asserted . "There are Minutemen belonging to the Dallas police force and Minutemen all over the place.

"But the Minutemen organization as such is not involved. There are several individuals who are identified with the John Birch Society but again the John Birch Society is not involved in any way."

Robertson, who frequently has taken issue with the Warren Commission's conclusions, put it this way
