Evangelist Designed Can For Cuban's Fund-Raising

Worked With Cuban, Beckham Reports

Thomas Edward Beckham, the evangelist-entertainer, sought to testify in the New Orleans probe of the assassination of President Kennedy, said Sunday he helped raise funds for Cuban revolutionary forces in New Orleans in 1962.

Mr. Beckham, 31, said he now is staying with friends in Council Bluffs after checking out of a motel there Saturday. He said he moved to Iowa in an effort to avoid a subpoena to New Orleans to testify in the assassination probe being conducted by Orleans Parish (county) District Attorney Jim Garrison.

Mr. Beckham, who says he is a bishop of the Universal Life Church, had lived in Omaha from April until Friday night. He also travels as a country western singer, using the stage name of Mark Evans.

Designed Label

Interviewed in Council Bluffs Sunday afternoon, Mr. Beckham said he aided Sergio Arcacha y Smith of Dallas in raising funds by obtaining collection cans and designing a label for the cans.

In a previous interview Mr. Beckham denied knowing Mr. Arcacha.

Mr. Arcacha also has been sought by Mr. Garrison to testify in the probe. Mr. Garrison has sought to link Mr. Arcacha with the Central Intelligence Agency. He has accused the CIA of trying to bury his investigation.

The fund-raising took place while Mr. Beckham was working as a "pew" of the Old Orthodox Catholic Church of North America in October, 1962, he said.

Assigned to Church

He said he was "ordained" as a priest in a ceremony by a bishop of the church in New Orleans about three months earlier, then received an assignment in October, 1962. In the meantime, he said, he opened a church in an old store building slated to be torn

involved following people involved in domestic relations cases, he said.

Mr. Beckham said the detective agency was in or near 531 Lafayette Street.

Mr. Garrison said that Mr. Beckham "associated with David Ferrie and others at 531 Lafayette Street, which was the same office building described as 544 Camp Street, the address originally used on leaflets handed out by Lee Oswald in New Orleans." Oswald was named by the Warren Commission as the as-

assin of President Kennedy.

But Sunday Mr. Beckham repeated his denial that he ever knew Oswald. He also denied that he had ever met with Mr. Ferrie more than once, and said that meeting was only for 10 minutes.

Mr. Beckham also repeated his contention that Mr. Garrison should subpoena Jack S. Martin, Sr., a private investigator in New Orleans, because he knew many of the people sought to testify in the Garrison investigation. He said it was through Mr. Martin that he met Mr. Ferrie.

New Orleans Private Eye Says Beckham 'Using' Him

Detective Advised Omaha Evangelist

A New Orleans private detective complained Sunday that he is being "used" by Omaha Evangelist Thomas E. Beckham.

"I've helped him out of jams before, and he apparently thinks I'll do it again," said Jack S. Martin, Sr., whom Mr. Beckham has described as a "hatchet man for Jim Garrison."

Mr. Beckham was subpoenaed as a material witness Friday in New Orleans District Attorney Jim Garrison's investigation into an alleged conspiracy leading to the assassination of President Kennedy in 1963.

When he learned of the court action, one of the first remarks made by Mr. Beckham was: "Why don't they subpoena Jack Martin? He knows all those guys mixed up in the thing."

'Never Met Oswald'

Interviewed by telephone Sunday, Mr. Martin said he has known Mr. Beckham for "about 10 or 15 years" and has advised him on a number of legal matters.

Mr. Beckham claimed he had never met Lee Harvey Oswald, named by the Warren Commission as the assassin of President Kennedy, but Mr. Martin said he has seen pictures of Mr. Beckham in the company of Oswald while passing out anti-Castro leaflets in New Orleans as part of a Cuban exile militant movement.

Mr. Martin said it was "possible" that he had introduced Mr. Beckham to David Ferrie, the former airline pilot who died last February and has been identified by Mr. Garrison as one of the conspirators in the so-called assassination plot.

10-Minute Meeting

He said he had met and talked to Mr. Ferrie on several occasions while representing him on a criminal action filed by New Orleans police. He said Mr. Beckham may have been along on such a visit.

Mr. Beckham told The World-Herald that his only

during a 10-minute episode with Mr. Martin "in late 1961 or early 1962."

He has denied ever meeting Lee Oswald.

Saw Pictures

Said Mr. Martin: "I can't swear that Beckham ever knew Oswald, but I saw the pictures and I know (District Attorney) Garrison has copies of those now." He said the photos were taken by a New Orleans television station while producing a documentary program on the Cuban movement.

Mr. Martin said he never was employed by the Garrison office but had, on occasion, "helped out," and has received "expense money." He said that so far as he knows Mr. Beckham has never worked with the District Attorney's office as he claimed.

Mr. Beckham's "ordination" as a priest in the Old Orthodox Catholic Church of North America, Mr. Martin said, was obtained by "mail order" from a man in Toronto, Canada.

Exile Haven

"He (Mr. Beckham) opened a mission on Rampart Street and came to me asking if I could get him some religious papers," Mr. Martin said.

"I told him about the guy in Toronto." He described the mission as a haven for Cuban exiles in the predominantly non-white section of New Orleans.

At the time, he said, Mr. Beckham wore black suits with a Roman collar.

Even though he admitted being acquainted with many of the persons linked with the Garrison investigation, Mr. Martin described his role as "insignificant."

"I've talked to them. I've told them everything I know," he said. "Garrison won't subpoena me, and neither will the other side. I don't have that much to offer."

More Than Angry

He said he "can't understand" why Mr. Beckham is reluctant to appear before the Orleans Parish (county) Grand Jury.

"If he doesn't know anything," Mr. Martin said, "why is he afraid to go down there to tell them so?"

He said he was "more than angry" that his name had been brought up by Mr. Beck-
