

Shaw Given Permission To Leave N.O.

Clay L. Shaw, charged with conspiracy to murder President John F. Kennedy, was granted judicial permission today to leave New Orleans from Sunday through Friday, Jan. 12, for a visit to the Mississippi Gulf Coast.

Attorneys for Shaw, in filing the motion asking permission to leave the jurisdiction, pointed out that Shaw is presently free on \$10,000 bail and that Shaw's attorneys would have his address and telephone number on the Gulf Coast if he should be required to return to the jurisdiction prior to Friday.

Shaw promised to return on three hours' notice from his attorneys.

Judge Edward A. Haggerty Jr. granted the motion. There was no opposition from Assistant District Attorney James L. Alcock, representing the state.

Aubrey Young Is Held in Jail At Baton Rouge

BATON ROUGE (AP) — Aubrey W. Young, former aide to Gov. John McKeithen and the star witness in the East Baton Rouge Parish grand jury probe of rackets influence in state government, was being held in jail today on an observation warrant.

Sheriff's deputies last night took Young into custody at a local bar. They said the pickup was on authority of Dr. Chester A. Williams, parish coroner.

Young was released from the alcoholism ward at the Southeast Louisiana State

Hospital at Mandeville so he could testify before the grand jury.

AFTER YOUNG testified, the jury indicted D'Alton Smith, a New Orleans contractor, on a charge of public bribery.

Dist. Atty. Sargent Pitcher obtained a full release for Young from the hospital at the height of the grand jury probe.

The coroner could not be reached for comment.

Young has also testified before grand juries in New Orleans in connection with crime probes there.

HIS TESTIMONY revolved around an alleged bribe offer to a local Teamsters boss to buy former Teamsters Union president Jimmy Hoffa's way out of prison.

Pitcher said Young served as middleman in a deal to free Hoffa, who was convicted of jury tampering.

Edward Grady Partin, Teamsters business agent in Baton Rouge, said he was offered \$1 million to change his key testimony at Hoffa's trial. Partin turned state's evidence against Hoffa.

Wimberly Appointed to DA's Staff

Shirley Wimberly Jr., 44, 6028 Catina, a retired Air Force legal officer and son of the late Judge Shirley Wimberly of the Criminal District Court, was today appointed to the staff of the district attorney's office.

Wimberly retired recently after serving 20 years in the Air Force. A legal officer, he retired with the rank of major.

The new assistant district attorney is married to the former Miss Mildred Salzer, and has a son, Stephen, 15, and two daughters, Ann, nine, and Mrs. Kathleen Plumstead.

He is a graduate of the Tulane Law School, and was in private practice about 15 months before returning to the Air Force, a branch of service in which he served during World War II.

His appointment to the DA's staff was announced today by first assistant DA Charles R. Ward.
