## Coppola Gives Testimony to Ethics Panel

BATON ROUGE -Lafayette Coppola, Roland state police commander who was linked in news reports to underworld boss Carlos Marcello and temporarily sus-pended, today testified for less than an hour before the Commission Louisiana Governmental Ethics.

The suspension had been ordered last September after th governor conferred in New York with Life magazine editors over the stories and came back to the state calling for a clean-up of vice activities.

-"We feel nothing will come of it," Schonekas said after he and Coppola emerged from the ethics commission meeting in the Civil Service Building.

Also testifying before the commission on the Coppola case was David Chandler of

Afterwards, his attorney, Russell Schonekas of Metairie, declared that Coppola had answered all of the questions put to him.

He predicted that nothing would come of the probe, which was launched at the insistence of Gov. John J. Mc-Keithen following a series of stories on organized crime in Louisiana by Life magazine.

M'KEITHEN ordered Coppola suspended pending the outcome of an investigation into his alleged relationship with Marcello, but the officer was ordered reinstated by the Civil Service Commission.

CHANDLER WAS later seen in the company of Gov. Mc-Keithen, who has named him as a special investigator with the state police while still working with Life.

Gen. Thomas Burbank, head of the Department of Public

Safety, also testified.

The Coppola case took up
the entire morning for the commission, which planned to resume work this afternoon.

No decision on the state police captains' case is expected today and one may not be forthcoming for several days. At this point the only thing the ethics commission may do is call a public hearing on allegations against Coppola or drop the matter.

The ethics commission also has on the agenda charges against the chief investigator for the state Labor-Manage-ment Board of Inquiry that he used his position to line up business for his own private firm

A. Harry Roberts, president of Southern Research Co. of Shreveport, revealed that he was under investigation by the ethics commission and said it was another effort at harass-

ment of the agency.

ONE OF THE ethics commission members is Victor Bussie, head of the state AFL-CIO, who has been at odds with the operation of the labor-management board.

Roberts has stoutly denied that he used his state position as charged and said he has been unable to find out who leveled the charge against him.

The ethics probers also may try again to resolve their indecision over the case of Rep. Lantz Womack of Franklin Parish, who received per diem from the Louisiana Financial Assistance CommisNYTimes

## U.S. WORKER CALLED IN KENNEDY 'PLOT'

NEW ORLEANS, Jan. 4 (UPI) -District Attorney Jim Garrison of New Orleans today subpoenaed a Federal civil service employe he said "may have special knowledge" of the assassination of President Kennedy.

The subpoena to appear before the Orleans Parish (County) grand jury went to a man identified as James Hicks, a civilian employe at Vance Air Force Base in Enid, Okla.

Mr. Garrison said that Mr. Hicks was at the scene the day Mr. Kennedy was shot in Dallas.

"Mr. Hicks may have special knowledge concerning the de-tails of the assassination with respect to its planning and ex-ecution as well as personnel employed in the assassination of the President," Mr. Garri-son said in a statement deliv-ered from his office.
