Hearing Hit at Plot Charge as Fraud

COLUMBUS (Ohio) — The former chief investigator in the New Orleans "assassination plot" swore yesterday District Attorney Jim Garrison's conspiracy is a "baseless fraud."

Assistant DA Gurvich, testifying as a state witness, charged Gordon K. Nease, Columbus, detailed for investigation under oath in Garrison's tenure as No. 1 New Orleans district attorney.

Nease, seeking the return of his former office of chief investigator to him on the day before Nease left Columbus, charged that he was "misled" into investigating the case.

He said he was probably influenced by Nease, who called along with other witnesses, author of this reporter, to testify in Nease's alleged favor in the case.

THE INTRIGUE

But Gurvich wound up telling an Iwan-the-turkle tale of intrigue and misuse of power in the office of Garrison. These were some of his sworn revelations:

assassination probe would end with the chief defendant charged with conspiracy in its suicide.

• Garrison once ordered Garrison to arrest, handcuff and search two NBC newsmen, Roger Sheridan and Robert Brownley, who had been critical of Garrison's investigation.

• Garrison changed his mind weekly and sometimes daily, and over-all had taken seven different views of the case — none of them very substantial.

• In 1964, Garrison's trial manager, Harry L. Holden, turned over to Gurvich a list of names he believed to be liars.
