ANSWERING CRITICISM that the current session of the Legislature has failed to accomplish anything, McKeithen rattled off a number of measures which passed both houses ures which passed both houses and said he thought the Legis-lature had accomplished many things.

Among the measures the governor cited were coordina-

tion of higher education, urban renewal and highway safety.

"That's probably the most ridiculous thing I've ever heard," he said, "that this man might not be convicted because his diary was revealed."

LOS ANGELES Mayor Samuel Yorty shortly after Sirhan was captured released information found in the young Arab's diary saying "Ken-Arab's diary saying "Ken-nedy must be killed before June 5."

June 5."

"I think the whole country was entitled to know what was in that diary," Mc-Keithen declared.

"They talk about the rights of the criminal, but what about our rights? What about the rights of the people who obey the law? Ain't we got some rights too?" some rights too?"

HE ALSO BLASTED contentions that the entire country was responsible for the Kennedy killing.

"If we're guilty of anything," he said, "we're guilty of being too good."
