SHAW, 55, IS 6-4 AND WEIGES 205. HE HAS SHORT, WAVY ALMOST-WHITE HAIR AND A BROAD FACT UITH PROMINENT CHEEKBONES.

A HEAVY SMOKER, SHAW SITS IMPASSIVELY IN THE COURTROOM. HE FOLLOWS EVERYTHING RATHER INTENTITY.

HE WAS BORN IN KENTWOOD, LA. ABOUT 50 MILES NORTH OF NEW ORLEANS AND JUST BELOW THE MIGSISSIPPI LINE. AN ONLY CHILD, HE CAME TO NEW ORLEANS AT THE AGE OF FIVE, LEFT 17 YEARS LATER FOR NEW YORK WHERE HE SFENT SEVEN YEARS IN ADVERTISING AND PUBLIC RELATIONS. HE ENTERED THE ARMY MEDICAL CORPS AS A PRIVATE IN WORLD WAR III. AND MADE THE RANK OF MAJOR IN THE GENERAL STAFF CORPS IN THREE YEARS.

SHAW WAS AIDE DE CAMP AND LATER DEPUTY CHIEF TO GEN. CHARLES THRASHER WHO HAD COMMAND ASSIGNMENTS IN ENGLAND AND NORTH FRANCE. SHAW'S DECORATIONS INCLUDE THE FEDREM CROIL DE GUERRE,

RETURNING TO NEW ORLEANS IN 1947, HE TOOK ON THE JOB OF ORGANIZING THE INTERNATIONAL TRADE MART WHICH OPENED IN 1948.

A PRIVATELY SUPPORTED AND NOMPROFIT ORGANIZATION FOR PROMOTING TRADE DIRECTOR, HE RETIRED OCT. 1, 1965, SAYING HE WOULD DEVOTE HIS TIME TO PERSONAL INTERESTS AND REAL ESTATE HOLDINGS.

SHAW HAS WRITTEN SEVERAL PLAYS. ANOTHER DIVERSION IS TRANSLATING FROM SPANISH. AT THE TIME OF HIS ARREST, HE WAS WORKING ON A PLAY ABOUT THE FIRST SPANISH COVERNOR OF LOUISIANA.

HE DESCRIBES HISSELF AS A LIBERAL IN POLITICS.

AND HE HAS SAID HE VOTED FOR JOHN F. KENNEDY FOR PRESIDENT. SHAW, A BACKLOR, HAS NO IMMEDIATE FAMILY EXCEPT HIS MOTHER WHO LIVES IN HAMMOND, LA. HIS FATHERER. HE YEARS AS MANAGING ON PLAY ABOUT THE FIRST SPANISH COVERNOR OF LOUISIANA.

DIST. ATTY. JIM GARRISON, 46, IS AT THE STORM CENTER. HE IS BIG, 6-6 AND 220, AN IMPOSING FIGURE EVEN WITHOUT THE REVOLVER HE WALSY HAS STRAPPED TO HIS BELT.

HE WAS FOUND DEAD IN BED, NUDE WITH A SHEET DRAWN UP UNDER HIS ARMS, ON FEB. 22, 1967. SOON AFTER GARRISON STARTED HIS INVESTIGATION. GARRISON CALLED THE DEATH SUICIDE. THE CORONER SAID IT WAS NATURAL, RESULTING FROM A BRAIN HEMORHHAGE. AN UNDATED NOTE FOUND IN THE APARTMENT SAID: "TO LEAVE THIS LIFE IS, FOR ME, A SWEET PROSPECT."

FERRIE, WHOM G FERRIE, WHOM G (MORE) KX1155PCS CW-NU NY GENERAL DESK: ADD CLAY SHAW TRIAL ADVANCE X X X SWEET PROSPECT. FERRIE, WHOM ORISON SAID HE PLANNED TO ARREST,
