D.A. Violated Sacred Rule, Connick Says

District attorney candidate
Harry Connick told a high school
assembly today that Jim Garrison "violated a sacred precept attorney of his office when he knowingly prosecuted a man although his evidence was clearly not good enough to obtain a conviction."

Connick, addressing Metairie Connick, addressing Metairle Park Country Day students, in an apparent reference to the Clay Shaw case, said, "When a district attorney accuses some-one, he must be fair and he must have the evidence. To do

must have the evidence. To do less goes against the very grain of our democratic society."

CONNICK ADDED: "I am very sorry to say that we have all been the victims of a district attorney who has placed his own desires ahead of the good of the people of New Orleans."

The DA candidate told the students that Garrison has often indicted but rarely convicted. He said Garrison has at various times accused the criminal court indges, the Legislature and Clay Shaw of misdeeds but has

convicted none of these.

Connick charged that Garrison has "enjoyed a seven-year reign of fear."

He told the students that Gov. John J. McKeithen has said publicly he would not want to cross Jim Garrison. "Every day, responsible businessmen tell me they are glad I'm running against Garrison but they are afraid to publicly support me," Connick said.

HE ALSO PRAISED John J. Petre, the first mayoral candi-

date to endorse Connick.
"John Petre told me he feared how Garrison might react against him if Garrison were returned to office, but Petre said he felt the endorsement of me was a matter of principle," Con-

Connick said if he is elected, he will introduce a program of

prosecution, rehabilitation and education into the DA's office. He said he would prosecute professional criminals, fight for professional criminals, fight for rehabilitation programs for first offenders and develop educa-tional programs for young peo-ple "who may be considering trying their first pill or mari-juana cigarette."
