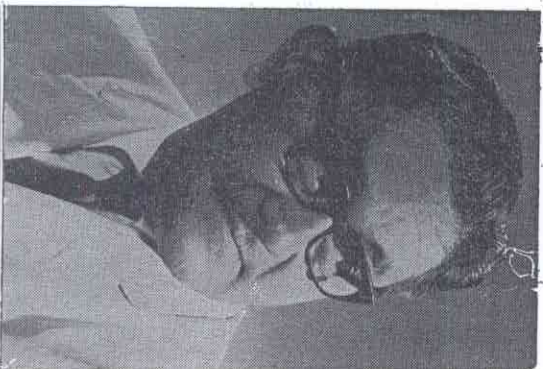

That the early appointment of Dr. Chetta's successor is advisable due to the importance of the position and the duties required in these times of crime explosion;

That Dr. Ignacio Medina, Jr. has manifested a thorough knowledge of the office of Coroner and a sincere dedication to it;

That it is respectfully recommended to his Excellency, John McKeithen, Governor of the State of Louisiana, that Dr. Ignacio Medina, Jr., be forthwith appointed Coroner for the Parish of Orleans as soon as possible to preclude any question of the legality of the vital functions of the office during the interim of the death of Dr. Chetta and the appointment of his successor.

Medina Favored for Coroner

In Poll of Orleans Doctor

One out of every two doctors recommended Dr. Ignacio Medina for coroner of Orleans Parish. A poll of Orleans Parish medical society members showed today.

Dr. L. Sidney Chantant, secretary, said the poll revealed results of a secret ballot. Dr. Frank Minyard, 54 votes, or 8 per cent. Spoiled ballots, 91, or 14 per cent.

Dr. Chantant said this is the first time in the society's history such a poll was taken.

Poll Indicates Medina Backing

A poll of members of the Orleans Parish Medical Society has shown that Dr. Ignacio Medina is their choice for coroner of Orleans Parish.

The society's ballots were secret so no one could tell which physician would be elected. Results were as follows: Dr. Medina, 334 votes; Dr. Carl H. Bagert, 137 votes; Dr. Frank Minyard, 54 votes.

Dr. Chantant said the poll was taken at the first meeting of the society's executive committee.
