Judge Haggerty is charged with soliciting for prostitution, obscenity and resisting arrest following his arrest Dec. 17 in a vice squad raid on a party at the DeVille Mo-Motel, 3800 Tulane Ave.

Zibilich this morning moved that the court compel the state to reveal the names and addresses of participating informer witnesses prior to a hearing on a motion to suppress.

Judge Haggerty's attorney also filed motions for bills of particulars in all three misdemeanor charges.

In his motion to consolidate for a speedy trial, Zibilich stated that the alleged offenses occurred in one continuous time element and should be adjudicated at one court hearing.

In his brief, Zibilich asked if Judge Haggerty had been "dragged" back to the motel room after the arrest so that television cameramen could photograph the judge being apprehended.
