MARCELLOS QUIZZED BY JURY

Two more members of the Carlos Marcello family were expected to be called before the federal grand jury this afternoon before it winds up the current phase of its investigation into organized

Due to testify this after-noon were Joseph C. Marcello, a son of Carlos, and Anthony

Marcello, a brother of Carlos.
The jury heard five witnesses today before a one-hour recess at 12:45 p.m. They were Peter Marcello, another brother of Carlos; Stefano Maggio and his sister, Concetta Maggio, both of Detroit; Luigi Santoro, a broth-er-in-law of the Maggios, and Charles Parinello of Detroit.

U.S. ATTY. Gerald J. Gallinghouse said during the noon recess today that some witnesses were yet to be called this afternoon whose names have not yet been made public.

Peter Marcello was the first witness called today. He entered the jury room at 10:45 a. m. and exited 40 minutes

At 11:30, the jury called Mrs. Maggio, who speaks only Italian. Court attaches said an interpreter would be provided for her in the jury

The jury is probing, among other things, the illegal reentry of Carollo into the U.S. from Italy.

Carollo slipped back into the country for the second time about Feb. 21 after being deported to his native Italy and immediately was hospitalized. He is under treatment at Touro Infirmary for a serious heart condition. Carollo, now 74, is a onetime Mafia leader in the New Orleans area. After his last illegal re-entry he was found hiding out in the Slidell area.

Attorneys for the Carollo and Marcello families said today Parinello apparently has no connection with either family. They said Parinello had been called by the U.S. attorney's office but had no legal representation before the jury.

SEVERAL LEGAL efforts were made yesterday by Marcello, his relatives and employes and the relatives of Carollo to avoid the grand jury appearance.

Attorneys for Marcello and his group yesterday took their case before Judge Mitchell to no avail.

Attorneys G. Wray Gill and Cecil Burglass Jr. for the Marcello group made the plea on Fifth Amendment issues, asserting the witnesses could

THE ATTORNEYS asked to accompany their clients into the jury room to advise them.

Judge Mitchell ruled the witness must appear before the jury or be in contempt of court and must appear with-out the benefit of attorneys but could protect their rights by refusing to answer any questions they felt incriminatory.

Carlos was the first of the Marcello family called. He entered the jury room at 1:30 p.m. and stayed for two hours.

OTHERS WHO appeared before the jury after Carlos Marcello were Jeff Hampton, his son-in-law; Dorothy Crowder and Mrs. Anna Saik, identified as his employes; attorney Philip Smith and Salvador J. Marcello, a brother.

Vincent Marcello, a brother of Carlos, and Carlos' son, were called but did not answer. Attorneys Gill and Burglass said both were ill. The U.S. attorney was handed medical certificates for both.

Names of two other brothers, Anthony and Joseph Jr., were called by a deputy mar-shal but the attorneys said they were not present be-cause they had not been served with subpoenas.

They were expected to be present today.

During the afternoon session, attorneys Dean A. Andrews Jr. and Michael F. Barry asked the Fifth Circuit Court of Appeals to stay the grand jury proceedings with regards to the family of Carollo but no action was taken. Also to testify today were two sons, Anthony and Michael Carollo; a daughter, Mrs. Sarah Misuraca, and her husband, Victor Misuraca; and Lingi Santori of Detroit.
