NEW ORLEANS - (AP) - District Attorney Jim Garrison, two New Orleans policemen and two other persons were arrested today on federal charges of taking up to \$1500 a month to protect illegal gambling with pinball machines.

In Washington, Atty. Gen. John Mitchell said arrest warrants issued last night in New Orleans charged Garriand the others with bribery, illegal gambling and obstruction of law enforce-

Garrison came to national

attention through his attempts to prosecute businessman Clay Shaw for what Garrison said was a conspiracy to assassinate President Kennedy.

Mitchell said criminal complaints against Garrison and the four other persons who were arrested, plus five others who are being sought, resulted from a year-long investigation by the Justice Department's organized crime strike force in New Orleans.

that accompanied the complaint, Garrison and New Orleans police officials Frederick Soule Sr. and Robert Frey received payments of as much as \$1500 a month to protect illegal gambling in coin operated pinball machine operations.

The affidavit said the government has tape recordings of some transactions between the lawmen and owners and operators of the pinball machines.

## Intermediary


The Justice Department said Pershing Gervais, a former investigator for Garrison, acted as the intermediary for the payments and recorded the conversations for the government.

Named in the complaint, in addition to Garrison, Soule and Frey, were six owners or operators of amusement firms using pinball machines and the chief lobbyist for the pinball machine industry in the Louisiana state legislature.

They were identified by the Justice Department as Louis Boasberg, 60; John Elms Jr., 29; Lawrence LaGarde, 52 Harby Marks Jr., 57; Robert Nims, 40; and John Elmo Pierce, 54. The lobbyist was identified as John Callery,

Garrison, Soule, a police captain assigned to Garri-son's staff; Frey, a vice squad sergeant; Broasberg and Marks were apprehended by federal agents today.

Gervais, chief investigator on Garrison's staff from 1962 to 1965 and a former private investigator and policeman, appears to be the government's main witness.
