Gervais Details Assertion Department

Pershing Gervais, the chief cog in the government's pin-ball gambling and bribery case against Dist. Atty. Jim Garrison, yesterday detailed his assertion that the Justice Department forced him to make a false affidavit against Garrison and then arranged fake jobs for him in Canada to keep him out of sight.

Speaking by telephone from Oregon to an interviewer in Vancouver, British Columbia, Gervais said his first job in Canada was to spy on the government for a major oil company-"to infiltrate, worm my way in and find out why this company wasn't given drilling rights like others."

But officials in the "higher echelons" of the unnamed

company backed down from the scheme on the advice of legal counsel, he said, leaving the U.S. Justice Department "hopping mad." However, the department was able to land him a job as "field traffic manager" with General Motors Convois and tors, Gervais said.

"THEY DICTATED to GM in Detroit, and Detroit dictated to Oshawa (GM's head-quarters in Canada)," he

said. The job was arranged, according to Gervais, while he and his family "sort of made our way slowly across the country like fourists heading for Vancouver."

The Justice Department,

which he said was sending him chough money "to get by on," finally ordered him to Washington, D.C., where he formally changed his name to Paul Mason. Then he was taken to Toronto by Gerald Shure a department official. Shure, a department official, and introduced to a man Shure said was president of GM in Canada, according to Gervais.
"Why he wanted to see me

I don't know," he said. "I guess he just wanted to see what this guy looked like who he had been told to hire. They took me out to the plant, introduced me to others and put me through a three-week

"I LEARNED NOTHING in that. I know as much about traffic management as I knowabout operating a linotype machine

"But it was all part of the payoff for the affidavit. The Justice Department had to give me money, and they had to know where I was and what I was doing. So they get the Canadian government and GM to cooperate down the

line."

The Justice Department, he said, then had the Canadian government provide him with a "minister's permit" allowing him to live and work in Canada from January, 1972, until January, 1973, despite his refusal to answer some of the duestions on the presserver. the questions on the necessary forms because answering them "would have been an outright lie."

The Justice Department also gave him a fake birth certificate for his son, who was then under the required age of six to get into the Vancouver school system, he said.
