Hunt was recruited into the CIA by Frank Wisner, deputy ass't sec. of war who had served as an OSS agent, WW II. Wisner helped set up the Office of Policy Coordination (OPC), ZZZZZ which later was integrated into the CIA.

Dr. James Burnham, professor of philosophy, NY University, introduced Hunt to Buckley; in 1950 when CIA assigned Hunt to Mexico "he soon brought Buckley aboard."

But as far as I knew, the records indicated that he was still a White House consultant to Colson. discussions of this by Colson, who at this point was disowning Hunt as a member of his staff, Ehrlichman called Mr. Bruce Kerhli and requested that he bring Hunt's personnel records up to Ehrlichman's office. .... When Kerhli arrived he was quizzed by Ehrlichman and Colson on Hunt's status at the White Colson was arguing that Hunt should have been removed as of March 31, 1972. Mr. Kerhli's records, however, did not so indicate . . . " - Dean, prepared statement, Washington Post 26 Jun 73. p. A9, col. 3

Threat - Hunt concedes in testimony before grand jury (Jan 74 - no exact date) that a threat was involved when he made his demand for money.

### Huht (3) Misc

Threats to blackmail White House. See entry 21 Mar 73, and AMP C that date. The dates of these threats, and implied threats, are "the latter part of 1972," "on or about November 30, 1972," and "12 or 13 Mar 73."

Hunt buys house near Exz Biscayne Bay (no date), described as "new and luxurious." Purchase price not disclosed; assessed for tax purposes at \$80,000, "and assessed valuations normally run considerably lower than true market value."

Note on Tad Szulc's book, by Maxine Cheshire, says Hunt may have had more than one copy of the files taken from his safe and given to Gray, and according to Szulc's informants, Hunt may have given one set of documents to a friend for safekeeping.

In testimony to grand jury (WX 2 May 73? - Los Angeles 6 Jun 73? - not specified) says CIA was called in to prepare psychiatric profile on Ellsberg only after burglary at Dr. Fielding's office failed to produce anything. Ehrlichman, according to "the latest private account ... provided recently to a Washington Post reporter [unnamed - Ungar?]" says Hunt and Liddy were told to provide material for the CIA's use in preparing the profile.

Literary agent, Donald MacCampbell, says 20 Jul 73 that Hunt suffered apparent stroke - no date -after fight in jail 10 Jun 73, and that he is deteriorating rapidly - both physically and psychologically." (See memo 20 Jul.) SFC [WXP] 21 Jul 73

Woodward and Bernstein say that, according to unnamed "government and non-government" sources, Hunt testified in closed-door session with government attorneys (for waxf (before Watergate grand jury appearance 2 May 73?) that New York apartment rented by Ulasewicz was to have been used to seduce women friends of Mary Jo Kopechne. Photos would have been taken secretly and then used to blackmail them into giving details on Chappaquiddick. Bittman confirms that Hunt gave such testimony.
