# Mollenhoff, Rogers In Shooting Match

#### Washington

Outgoing White House investigator Clark Mollenhoff quarreled angrily with Secretary of State William P. Rogers over obtaining a list of 250 State Department employees who criti-cized President Nixon's action in Cambodia.

I'm not going to say whether he shouted at me or I shouted at him," said Mollenhoff yesterday in a tele-phone interview from his summer home in Clarion, Iowa.

"My job requires you to be independent, to conduct in-vestigations and to criticize from time to time. If I didn't, I would be a damn fool. People on all levels of government once in a while are going to disagree."

The confrontation took place after Mollenhoff re-quested on May 18 that state supply him with names of 250 e m ployees of the depart-ment, AID agency and the Arms Controls and Disarmament Agency who signed a petition to Secretary Rogers opposing. U.S. involvement in Cambodia.

#### REFUSAL

State Department spokesman Carl E. Bartch said yesterday that Mollenhoff asked Deputy Undersecretary for Administration William B. Macomber for the list and that Macomber refused. Mollenhoff then obtained the names anyway from an undisclosed source in the department.

The confrontation with Rogers ensued within a day of Mollenhoff's request for the names. Rogers reportedly told Mollenhoff to stop interfering in the internal affairs of his department.

It was the second time in the last few months that Mollenhoff and Rogers have tangled ove, probes by the White House aide into the State Department. Early this year, Mollenhoff indicated he was investigating State's handling of relief to Biafra. Robers objected, and the White House subsequently ended the investigation.

Mollenhoff said his con-frontation with Rogers over

signers had "nothing to do with my resignation" an-nouncefent May 30.

### ADVERSARY

Mollenhoff, who is on two weeks vacation and will leave the Administration to return to newsper work in mid-july, said, "traditionally, the ombudsman who does his job properly will be in an adve,sary position with a wide range of government officials and personnel. The role re-quires investigations,"

The White House said yes-terday that Mollenhoff had acted "on his own volition" in his quest for the names. Press Secretary Rorald L. Ziegler said that Mollenhoff has not passed "he list on to anyone at the White Pouse, but he added. "he may."

Ziegler and Mollenhoff denied a dossier is being compiled on the petition signers.

Ziegler was asked whether Mollenhoff will be taking secret FBI and tax information that he has acquired during his 10-month tenure as a White House aide when he leaves next month.

Ziegler said he would "strongly quarrel" with any intimation that Mollenhoff is leaving the White House with extensive secret data he has compiled on the job.

White House sources said no decision has been made on whether to replace Mollenhoff, who was charged with ferreting out wrongdoing inside the Administration, or whether to assign his duties to a current staff member.
