

# Mitchell Plan for College Seminars

Washington

Colleges in 33 states have been selected by the Justice Department for its new campaign to woo the Nation's young.

Attorney General John N. Mitchell said yesterday he has written to the heads of 51 colleges and universities asking if representatives of his department may visit their campuses for informal question-and-answer sessions

with students. "We hope that this kind of exchange of information and views will be beneficial to all concerned," he told the college presidents.

Mitchell disclosed in August that he wanted to establish better rapport with young people the Justice Department said it has not yet been determined whether he will visit any of the campuses.

## Officials of Justice Department To Meet Students on Campuses

WASHINGTON, Sept. 29 (UPI) — Attorney General John N. Mitchell announced today that top Justice Department officials, including himself, would visit college campuses from Maine to California for face-to-face discussions with students.

Mr. Mitchell said the sessions to be scheduled in October and November, were intended to improve communications between his department and college students.

The list includes schools in 32 states and the District of Columbia. Four of the schools are predominantly Negro.

Absent from the list are the University of California's Berkeley campus, Columbia University in New York and the University of Wisconsin at Madison, scene of a recent fatal bombing.

In letters to the heads of the institutions to be visited, Mr. Mitchell said:

"As you know, the Justice Department's areas of responsibility — such as law enforcement, civil rights, and environmental quality — are also subjects of deep interest to many younger Americans.

"For that reason we are plan-

ning a series of visits to representative campuses in which top officials of the department can meet informally with interested students, in whatever form you deem appropriate, and answer questions about the department's policies and programs."
