did not figure in the October peace formula.

The first of the nine points, in the text released by Hanoi Oct. 26, stated that "the United States recognizes the independence, sovereignty, unity and territorial integrity of Vietnam as recognized by the 1954 Geneva agreement."

Hanoi's delegation again referred to this stipulation today

and called on the United States to respect its commitments. The fifth point calls for "reunifica-tion of Vietnam, step by step, through peaceful means."
