Pacific Corporation

Incorporated in Delaware in 1950; shares privately held, mostly by the five members of board of directors. Corporation and its subsidiaries employ about 9300 people.

Owens 100 per cent of Air America; owns 40 per cent of Civil Air Transport; a separate operating division is Pacific Engineering.

Owens 99 per cent of Air Asia.
