> Garrison forecast more arrests, "more than most people expect."

Details of the assassination plot charged by Garrison emerged Thursday in an affidavit filed earlier requesting a warrant to search Shaw's luxurious French Quarter apartment.

Garrison's affidavit also

identified Shaw as "Clay Bertrand" and a witness who had some contact with a Clay Bertrand in connection with the assassination was subpoeaned to appear in Garrison's office Thursday.

Dean A. Andrews, an assistant district attorney in neighboring Jefferson Parish (County), arrived at Garrison's office about 5 p.m. and was still closeted with Garrison more than ttwo hours later.

Andrews told the Warren Commission, that investigated the assassination that he received a call from a man named Clay Bertrand after Kennedy's death requesting he represent Oswald.

Bertrand, Andrews said, had contacted him occasion-ally on behalf of "gay kids" and "kooks", usually by telephone.

Andrews told the Commission he was ill at the time and: referred Bertrand to Sam Monk Zelden, who accompanied Andrews to Garrison's office as his attorney Thursday.

Shaw denied any connection with Oswald and said he never had used an allas. Garrison's affidavit said the conspirators, among them a "confidential informant," met in Ferrie's uptown apartment to make their plans.

FERRIE BURIED

Ferrie, 49, was buried in nearby Chalmette Wednesday, a few hours before attended the funeral. Shaw's arrest. Three persons Garrison's affidavit said the conspirators met in Ferrie's rooms during September, 1963, and "at these meetings there was an agreement and conclusion . . . to kill John F. Kennedy.

Andrews testified before the Warren Commission that Oswald came to his office several times in the summer of 1963 to seek advice "on a less than honorable discharge from the armed services" and about the citizenship status of both Oswald and his Russianborn wife, Marina.

Annison's search warrant application for Shaw's apartment asked for authority to seize "photographs, letters, political propaganda, maps, newspapers, telegrams, can-

celled checks, diagrams, blueprints . . . copies of manuals, manuscripts, recordings, ledgers, cancelled airplane tickets, telephone vouchers, tools and implements, guns, rifles, ammunition, telescopic sights, parts." miscellaneous gun

Garrison's agents entered Shaw's apartment Wednesday and carried out five boxes of assorted items and a rifle in a canvas case.

Shaw, former managing director of the New Orleans International Trade Mart, is not mentioned in the Warren Report. An associate de-scribed him as an admirer of President Kennedy and Acting Atty. Gen. Ramsey Clark said in Washington he had been investigated but cleared by the FBI after the assassination.

The search warrant ap-plication said an informant attended the alleged meetings at Ferrie's uptown apartment on tree-shaded Louisiana Av. Parkway.

INFORMANT QUOTED The informant "was present at these meetings and saw

at these meetings and saw the conspirators and heard the plan," said the warrant application. "This confidential inform-ant saw David W. Garrison's request for the warrant said the informant after divulging the informa-tion "voluntarily submitted to sodium pentothal (truth serum), which was administered under the care and con-trol and supervision of the coroner for the Parish of Orleans, a medical doctor. "That the confidential in-

rorborated and re - affirmed his earlier statements." Shaw, at a news conference in Atty. <u>Edward Wegman's</u> office Thursday afternoon, maintained he was "com-pletely innocent" of the charges made against him.
