Shaw Pleads Not Guilty to Plotting Kennedy Death

NEW ORLEANS, April 5-Clay L. Shaw pleaded not guilty at his formal arraignment today on charges of having conspired to murder President Kennedy.

The arraignment was over in four minutes. Defense attorneys predicted that the retired New Orleans business executive would go on trial within three to six months.

Meanwhile today, an Orleans Parish (county) grand jury, which is probing the assassi-nation under the direction of District Attorney Jim Garrison, indicted a New Orleans man on perjury charges growing out of the investigation.

He is Layton Martens, roommate of the late David W. Ferrie, who Mr. Garrison says conspired with Mr. Shaw. Bond was set at \$2,500.
