Nixon "angered and distressed" by new evidence presented

against another. He was creating an environment in which  
the prosecution could carry out its investigation," and  
that Nixon used the period between 15 and 30 Apr "very  
wisely to help the government develop evidence."

Ehrlichman memo [on discussion with Colson and others 15 Apr] "[contain] a strong suggestion that concern over the Federal grand jury testimony of E. Howard Hunt Jr., ... had prompted Mr. Nixon's April 17 announcement of 'serious' new charges in the Watergate case. .... Mr. Ehrlichman confirmed to a reporter that his notes [on this meeting] reflected a recommendation by Mr. Colson that Mr. Nixon should publicly disclose 'damaging evidence' so that a pending grand jury appearance by Hunt would be an 'anti-climax'."

Gray receives "short, terse" phone call from Ehrlichman, about 15 seconds long, to inform him that Dean had been talking to the prosecutors. This call was at about 10.30 p.m. and was followed by another, equally short, at 11 p.m.; the second reported that Dean had told the prosecutors about having turned the Hunt papers over to Gray. (For contradictions in Ehrlichman and Gray versions, see story by Lawrence Meyer, WXP 4 Aug 73; suggestions can be read into it that Gray was being put on record to take the full blame for destroying Hunt files.) Gray: "I realize that the conversations may have been recorded without my knowledge," and that Ehrlichman seemed "tense."

According to Haldeman, in deposition in Democrats' civil suit taken 22 to 24 May, these calls by Ehrlichman were made from Nixon's office; Nixon and Haldeman also were present.

\*From abbreviated summary of what is believed to be the contents of subpoenaed tapes: "April 15, 1973 - The controversial meeting between [Nixon] and Dean, in which [Nixon] said he had been 'joking' on March 13 when he made the remark about \$1 million payoffs to the defendants. .... 'If true and accurate, this [Dean] testimony would indicate an important dimension to the voer-up conspiracy,' Cox said.

'If false and misleading, a perjurious injustice has been done for which the grand jury can return ~~and~~ an indictment.' The White House said this conversation never was taped because of malfunctioning equipment. Although the President previously had told the Justice Department that he had a Dictabelt recording of his own recollections of the meeting, the White House on Nov. 12 said it cannot find the Dictabelt."

Nixon "grand tour" of Europe - Nixon tells newsmen he is planning to make a "grand tour" of Europe in the autumn. At a news conference 15 Mar 73 he had said he was considering such a trip this summer or late spring; NYT says this earlier trip had "reportedly [been] planned to dramatize his intention to make 1973 'The Year of Europe.'" But according to Administration officials, the President changed his mind about an early visit to Europe as a result of the strong criticism from many European capitals of the American bombing of Hanoi last December. Mr. Nixon - according to aides - was angered at what he regarded as a lack of understanding by his allies and decided to let considerable time elapse before going to Europe."
