Osorio, joined by the other defendants, has filed a motion asking Judge W.M. Taylor to order Nixon or his "authorized representative" to appear and produce tapes of conversations between Nixon, Mitchell and Tower about the Texas investigation. Carr has filed a separate, similar subpoena. The conversations in question are alleged to have taken place at the White House 29 Jul 71. Defendants allege that CRP engineered an investigative and prosecution scheme designed to discredit Democrats and help assure reelection victories in Texas for Nixon and Sen. John Tower.

Mrs. Hunt's wallet, found when she was killed, contained the names of two Washington doctors, Dr. Gary Morris, a psychiatrist, and Dr. Marvin Korengold, a neurolgist who had used hypnosis in his practice.

If Mrs. Hunt had consulted either doctor, there is no record of it. Dr. Morris and his wife disappeared Mar 72, apparently lost at sea in the Caribbean; his records and files contain no mention of Mrs. Hunt. Dr. Korengold says Mrs. Hunt was never a patient of his, and "If we could locate Mrs. Hunt's family doctor, he might clear up the mystery, but so far we haven't been able to."

Hunt should be able to provide the name of their family doctor, or any other treating Mrs. Hunt; photos could be shown Dr. Korengold, izx zinc where a some other name, or since she might have
