Cox - Round-up story says he refused to accept the Nixon "compromise" because he could not obey the directive to stop trying to obtain WH documents - but he was willing to submit it to Sirica and if the court accepted it, he would also. To comply with the directive would violate his promise to the Senate. Remarks were made at his press conference 20 Oct.

Cox, at press conference, says he had to turn down Nixon's compromise as soon as it was made clear that as the price of getting an ancount of the tapes, "I must abandon the fundamental of any impartial investigation that I be free to seek evidence wherever it was in accord with the rules of law."

"I think it's quite possible that the nine tapes will turn out to be less important in a practical sense than they have been in a symbolic sense. They were clearly only the first step in seeking a great deal of important evidence in the White House."

Chou En-lai, intv'd by C.L. Sulzberger, says Watergate has not affected relationships between United States and China; "You have had such things occur in your society before and undoubtedly will have them again. There are many social aspects [of U.S. society as a whole] interwoven into it. It is better not to discuss this issue."

Connally says Nixon owes the country a better explanation than he gave for firing Cox, and should have turned the tapes over months ago. (On Texas weekly press-panel television show.) See entry 30 Oct 73.

Inouye, speaking in San Francisco to Japanese American Citizens League, says promise by Nixon to surrender tapes to Sirca "eases the crisis, but my request (for his resignation) still stands.
