Nixon (taxes) - Rep. Wilbur D. Mills will head investigation by Senate-House Joint Committee on Internal Taxation of Nixon tax returns; committee is charged specifically with ruling on legality of Nixon's tax free sale of land adjoining his San Clemente property (profit, \$117,370), and the deduction of \$576,000 for giving vice presidential papers to the National Archives. Committee is composed of five senators and five representatives, of whom six are Democrats and four are Republicans.

California Franchise Tax Board will include the question of Nixon's tax status on the agenda for its meeting 11 Dec.

White House sources say if the two hearings go against Nixon he may have to pay \$296,333 in federal taxes and between \$15,000 and \$16,000 in California taxes.

Tapes - Sirica turns over to Jaworski tape of conversations excerpted from WH tapes and re-recorded on a single reel; the dates involved are 13 Mar 73 (Nixon, Dean, Haldeman) and 22 Mar 73 (Nixon, Dean, Haldeman, Ehrlichman, Nitchell).

Jaworski says that, in response to his requests, WH lawyers delivered 8 Dec a "significant number of tape recordings" and a "substantial number of documents;" does not say what they concern.

Warren also refuses to identify this material, says, "We have been cooperating with the special prosecutor in a private way as rational men seeking the same goal. We prefer to maintain confidentiality." Says WH is cooperating "completely" with Jaworski and that the special prosecutor believes his investigation will be "wrapped up soon." SFC 11 Dec 73 [NYT]
