Nixon (taxes, California) - "A knowledgeable White House official" says Nixon is anticipating a ruling from California Franchise Tax Board that he is a California resident, that Nixon has considered himself a California resident while President, and that he had followed the advice of his accountants and legal experts when he failed to pay state income taxes. Says Nixon has privately expressed willingness to pay these taxes.

If Tax Board rules Nixon is a state resident it would then have to make its own determination of the legality of his deductions for vice-presidential papers and his failure to pay capital gains taxes on resale of part of San Clemente property to Abplanalp and Rebozo. "One puzzling aspect of [his] failure to pay state income taxes is that the amounts involved would be small if the federal deductions were allowed, and virtually nothing at all in 1970 and 1971. However, the filing of California returns would subject the President to checks on the federal deductions by the state Franchise Tax Board." If deductions for the papers are not allowed by the Board, and it rules Nixon should pay capital gains taxes, his liability for four years would be \$90,000.
