"'Stress is not measurable,' [Dr. Tkach said]. 'Some people under stress get sick, others do not.'"

SFC 30 Apr 74 [LATimes, Robert C. Toth] - filed Nixon.

Ehrlichman - Nixon letter to Judge Gesell (who will preside at the trial of Ehrlichman and five others, set for 17 Jun) is placed under seal today by Gesell; presumably letter was written 29 Apr er today, and is in response to an order issued "last month"*by Gesell, who told special prosecutor's office to submit to the court*any evidence of Nixon's involvement in or knowledge of Fielding break-in.

In his letter, "according to some who [know] about it," Nixon says that those who broke into Dr. Fielding's office did so under his delegated authority. NYT: "Mr. Nixon said he made the full delegation of his presidential powers in an attempt to stem a series of newspaper leaks that he perceived to be a threat to national security and foreign relations." "In his previous public statements, Mr. Nixon has not discussed the Plumbers in terms of his delegation of presidential authority. He came close to that kind of assessment on May 22, 1973, [when he said] 'I must and do assume responsibility for such actions despite the fact that I, at no time, approved or had knowledge of them.'"
