Nixon addresses luncheon meeting of National Citizens Committee for Fair Play to the Presidency, tells 1400 participants that their support will strengthen him as he leaves tomorrow on what he describes as "a long and difficult journey" to five Middle East countries.

The meeting is devoted to praising Nixon and attacking the House Judiciary Committee, the Watergate grand jury, Cox, members of the special prosecutor's staff, and especially the press. All of the speakers, including Nixon, attack the press. "Each attack was greeted by roars of approval by the participants, who shook their fists and shouted imprecations at reporters and cameramen who were in a roped-off area." Story describes reaction at another point as "a deep gutteral roar interspersed by rebel yells and gestures at the reporters."

"Mrs. Nixon and her two daughters ... were honored at [the] luncheon. Mrs. Nixon remained silent as she accepted her honor, but both daughters spoke up in support of their father."

Calvin Kovens - (Undated story.) House Judiciary Committee investigators have been interrogating members of U.S. Parole Board about parole granted Kovens, who contributed #30,000 to Nixon re-election campaign.

Kovens, a Miami contractor, was convicted of wire fraud with Hoffa in 1964; hired as his lawyer former Sen. George Smathers (no date); Smathers called Colson 30 Dec 71 to ask for a parole, "invoking" Rebozo's name; parole was granted five days later, 5 Jan 72.
